The State Board of Elections at its meeting on August 27. 2014, approved a final version of amendments to its regulations dealing with material omissions from absentee envelope B, 1 VAC 20-70-20, and the voter statement accompanying the federal write in absentee ballot, 1 VAC 20-45-40. The Board agreed with the staff recommendation to limit the changes to those required by recent legislation (middle name or initial, date and seal) with one exception—omission of generational suffix may be material when voters registered at the same address have the same name and the voter identify cannot otherwise be determined.

2014 legislative amendments effective July 1, 2014, allow counting the ballot if the outer envelope is sealed and specify that neither omission of the date nor middle name or initial require rejecting the ballot if first and last names are provided. At its meeting on June 10, 2014, the State Board of Elections approved posting amended regulations for public comment that include two additional amendments dealing with generational suffix and street identifiers. The public comment period opened June 30, 2014, and closed July 21, 2014. A total of 87 comments were received. Most of the comments oppose treating generational suffix and street identifier as material. The Board at its meeting on August 27, 2014, approved final regulation amendments titled 2014 Absentee Material Omissions setting forth the legislatively mandated changes on middle name or initial, envelope seal and date, and a further amendment specifying that omission of generational suffix may be material when individuals sharing the same name are registered at the same address and the identity of the absentee voter cannot otherwise be determined.
