Pursuant to § 2.2- 4006 A 6 of the Code of Virginia, the Board of Counseling has reduced the application fee for a qualified mental health professional-trainee (QMHP-trainee) from \$50 to \$25.

Mandate and Impetus

Please identify the mandate for this regulatory change, and any other impetus that specifically prompted its initiation (e.g., new or modified mandate, internal staff review, petition for rulemaking, periodic review, board decision, etc.). The impetus for the change is legislation that was enacted by the 2019 defining QMHP-trainees and authorizing registration. The only registration fee set in regulation is \$50, so an applicant must pay that amount to register as a QMHP-trainee and then pay an additional \$50 to register as a QMHP-A or QMHP-C once he has completed his training. The Board believes the reduced fee of \$25 will encourage potential QMHPs to obtain training necessary for registration.

The Board is acting under an exemption in the Administrative Process Act relating to reduction of fees for applicants and regulants of board within the Department of Health Professions - 2.2-4006(A)(6).
