Pursuant to the 2009 Acts of the Assembly (SB1282 – Chapter 687), the Board of Medicine has amended its regulations relating to the responsibility of the licensee to provide current addresses. SB1282 requires that every licensee of the Board must provide an address of record for use by the Board and the Department, but permits a person to provide a second address to be used as the public address. If a second address is not provided, the address of record becomes the public address. Regulations are amended to use the statutory terminology of address of record and to clarify that the regulant has a responsibility to notify the board if there is a change in the public address as well as the address of record (if there is a difference).

Statement of final agency action

On June 25, 2009, the Board of Medicine acted to amend its regulations in Regulations Governing the Practice of Medicine, Osteopathic Medicine, Podiatry and Chiropractic (Chapter 20), Regulations Governing the Practice of Respiratory Care Practitioners (Chapter 40), Regulations Governing the Practice of Physician Assistants (Chapter 50), Regulations Governing the Licensure of Occupational Therapists (Chapter 80), Regulations Governing the Licensure of Radiologic Technologists and Radiologic Technologists-Limited (Chapter 101), Regulations Governing the Practice of Licensed Acupuncturists (Chapter 110), Regulations Governing the Licensure of Athletic Trainers (Chapter 120), and Regulations Governing the Practice of Licensed Midwives (Chapter 130). The action is exempt in the Administrative Process Act under § 2.2-4006 of the Code of Virginia.
