The impetus for this change was a petition for rulemaking that was received by the Board in May 2023 and which the Board accepted at its August 4, 2023 meeting.

Regulations of the Board of Medicine are promulgated under the general authority of Chapter 24 of Title 54.1 of the Code of Virginia. The Board has determined that the current requirements under 18VAC85-50-110(1), which require involvement in care of the patient care team physician or podiatrist when a patient presents twice for the same issue, to be overly restrictive on physician assistants and could negatively impact patients receiving care in a timely manner.

#### Substance

The Board will amend 18VAC85-50-110(1) to indicate that the patient care team physician or podiatrist shall provide appropriate consultation/collaboration for complex clinical cases and patient emergencies, as noted in the written or electronic practice agreement for the patient evaluation process.
