The Board of Pharmacy has amended its scheduling regulations contained in 18VAC110-20, Regulations Governing the Practice of Pharmacy, to remove chemicals and drugs placed in statutory schedules pursuant to action of the 2025 General Assembly. [HB1587](#) added changes to legislation which the Board adopted during the previous year.

Although the change is not mandated, [HB1587](#) added drugs and chemicals previously scheduled by the Board in statute. Therefore, the regulatory scheduling of those drugs and chemicals is no longer needed.

On May 19, 2025, the Board of Pharmacy adopted final amendments to 18VAC110-20, Regulations Governing the Practice of Pharmacy, by exempt action.
