The purpose of this proposed action is to amend section 12VAC5-481-451, "Increased controls and fingerprinting" to be compatible with 10 CFR Part 37.

The NRC created Code of Federal Regulations (CFR) Title 10, Part 37 (10CFR Part37), "Physical Protection of Category 1 and Category 2 Quantities of Radioactive Material" on March 19, 2013. Agreement States are required to implement compatible regulations within 3 years of this date or the program will be deemed "non-compatible" by the NRC, which may result in the revocation of Virginia's Agreement State status.

The NRC reviewed the proposed revision to 12VAC5-481-451 and provided comments in a letter dated February 19, 2015.
