The Auctioneers Board is amending existing regulations to conform to SB 1406, enacted by the General Assembly during the 2021 Special Session I. The marijuana legalization legislation limits dissemination of criminal history record information related to misdemeanor marijuana offenses, and prohibits state agencies from requiring disclosure of certain marijuana convictions during the occupational licensing process.

In order to comply with the statutory amendments, the Board has approved the exempt action to conform its regulations concerning qualifications for licensure and standards of conduct to the requirements of § 19.2-389.3 of the Code of Virginia. The final action will remove any reporting by applicants or licensees of misdemeanor marijuana convictions.

This action conforms the regulations to the law and is exempt from the Administrative Process Act because there is no agency discretion pursuant to § 2.2-4006(A)(4)(a) of the Code of Virginia.

The General Assembly enacted Chapter 550 during its 2021 Special Session I, mandating the Board update its regulations pertaining to disclosure of marijuana-related misdemeanor offenses by applicants and licensees in order to conform to the changes in § 19.2-389.3.
