(Background) The International Code Council (ICC) was established in 1994 as a nonprofit organization dedicated to developing a single set of comprehensive and coordinated national model construction codes. The founders of the ICC are Building Officials and Code Administrators International, Inc. (BOCA), International Conference of Building Officials (ICBO), and Southern Building Code Congress International, Inc. (SBCCI). Since the early part of the last century, these nonprofit organizations developed the three separate sets of model codes used throughout the United States. Although regional code development has been effective and responsive to our country's needs, the time came for a single set of codes. The nation's three model code groups responded by creating the ICC and by developing codes without regional limitation.

## Virginia Certification Standards:

§ 36-137 of the Code of Virginia (<a href="http://leg1.state.va.us/cgi-bin/legp504.exe?000+cod+36-137">http://leg1.state.va.us/cgi-bin/legp504.exe?000+cod+36-137</a>), requires the Board of Housing and Community Development (BHCD) to exercise, among others, the following power and duty; to issue a certificate of competence concerning the content, application, and intent of specified subject areas of the building and fire regulations promulgated by the Board to present or prospective personnel of local governments and to any other persons seeking to become qualified to perform inspections pursuant to § 36-97 et seq. of the Code of Virginia and any regulations adopted thereunder, who have completed training programs or in other ways demonstrated adequate knowledge.

Standards Governing Operation of Individual and Regional Code Academies/1990: § 36-137 of the Code of Virginia (<a href="http://leg1.state.va.us/cgi-bin/legp504.exe?000+cod+36-137">http://leg1.state.va.us/cgi-bin/legp504.exe?000+cod+36-137</a>), requires the Board of Housing and Community Development (BHCD) to make such rules and regulations as may be necessary to carry out its responsibilities. The Code of Virginia further requires the Department of Housing and Community Development to accredit individual or regional, training academies maintained by localities that retain the building permit fee levy authorized pursuant to § 36-105 to support such training programs.

The specific reasons the BHCD has determined that this regulatory action would be essential to protect the health, safety and welfare of citizens is that with the development of the ICC model codes, internationally available uniform education and certification programs may now be used by the BHCD for certification of code enforcement officials in Virginia. And this will lead to more consistent code enforcement and higher level of safe, quality construction.

Virginia Certification Standards:

The potential issue that may need to be addressed as the regulation is developed could be to not amend the regulation to require the National Association of Amusement Ride Safety Officials (NAARSO) amusement device inspector certification examination and leave the currently required examination to stay in place.
