DMAS is incorporating changes that have recently been made to the state plan into the Virginia Administrative Code. The changes allow DMAS to use Supplemental Nutritional Assistance Program (SNAP) income to support Medicaid eligibility determinations at the time of Medicaid application. DMAS already uses a similar strategy at the time of annual Medicaid renewals. Medicaid eligibility criteria will remain the same, and there will be no change in the number or outcome of eligibility determinations made as a result of these changes.

The Code of Virginia § 32.1 325, grants to the Board of Medical Assistance Services the authority to administer and amend the Plan for Medical Assistance and to promulgate regulations. The Code of Virginia § 32.1-324, grants the Director of the Department of Medical Assistance Services the authority of the Board when it is not in session. This rulemaking is expected to be noncontroversial because it does not have any negative effect on Medicaid providers or Medicaid members. The changes will streamline the eligibility process to make eligibility determinations both easier and faster. This will benefit DMAS, the Department of Social Services, and Medicaid members.

There are no changes in the number or outcome of eligibility determinations made as a result of these changes, and there are no costs associated with these changes.

The primary advantage of this regulatory action is it allows for DMAS to coordinate policies and processes with other state agencies to improve administration, customer service, and program participation. Research has shown that SNAP households have at least one member that receives coverage under Medicaid, and there may be additional eligible members. Due to similar eligibility requirements in the programs, using SNAP income to determine Medicaid eligibility will reduce the need for Medicaid participants to frequently reapply for benefits. This change will also reduce DMAS' need to request additional paperwork from members. There are no disadvantages to the public, the agency, or the Commonwealth as a result of this regulatory action.
