This exempt action removes the applicability to religious exempt child day centers of certain provisions because these centers are not licensed, registered, or approved, per provisions in the *Code of Virginia*. The action requires child-placing agencies to consider the results of background checks on a birth parent prior to placing the birth parent's child, who is in a foster care placement, with the birth parent per § 63.2-901.1 of the *Code of Virginia*.

The action also adds prospective foster parents to an already existing provision allowing, but not requiring, approval of adoptive parents convicted of assault or assault and battery under certain conditions, per action of the 2005 General Assembly. It further amends this provision by adding that the conviction may not have involved a minor. This provision's applicability to both prospective foster and adoptive parents is consistent with provisions of House Bill 2744, passed by the 2005 General Assembly, requiring that home study components be the same for foster and adoptive homes per § 63.2-906 of the *Code of Virginia*.

The State Board of Social Services took final action on 22 VAC 40-191, Background Checks for Child Welfare Agencies, on April 20, 2005.

Family impact

Assess the impact of this regulatory action on the institution of the family and family stability.

The *Code of Virginia* exclusion of religious exempt child day centers from waiver provisions provides additional security for families who place their children in settings that have less oversight. Conversely, not providing for repeat background checks for employees and volunteers in these settings could increase unease of parents about the safety of their children. This action maintains family stability by allowing licensed child-placing agencies to make the final determination if an assault or assault and battery conviction should be cause for denying approval of persons as adoptive or foster parents. Family stability will be enhanced because the background checks of birth parents will be considered prior to licensed child-placing agencies' placement of their children, who have been placed in foster care, with the birth parents.
