Sections 22 VAC-40-80-160 and 22 VAC 40-80-180 are amended to make the language consistent with § 63.2-1706 of the Code of Virginia especially changes that became effective July 1, 2010.

The first change to Section 22 VAC-40-80-160 specifies that applicants and licensees must at all times afford the department's representatives reasonable opportunity to inspect all of the facility's buildings. The second change to the section specifies that interviews with persons living or participating in a facility or under the facility's custody, control, direction or supervision of an applicant for licensure or licensee must be authorized by the person to be interviewed or his legally authorized representative and the interview limited to discussion of issues related to the applicant's or licensee's compliance with applicable laws and regulations, including ascertaining if assessments and reassessments of residents' cognitive and physical needs are performed as required under regulations of the Board. A correction to a regulation number was also made in this section.

The change to Section 22 VAC-40-80-180 specifies that for any assisted living facility issued a license or renewal for a period of one, two, or three years, there shall be at least one inspection each year, which shall be unannounced, and as needed based on compliance with applicable laws and regulations.
