### Summary

The statutory authority citations from the Code of Virginia for this APA-exempt regulation are §§ 33.1-12 and 33.1-18 of the Code of Virginia. The Virginia Department of Transportation (VDOT) has prepared amendments to the regulation to consolidate the types of public hearings required for projects on the interstate, primary, urban, or secondary systems of state highways. This action improves the understandability of the requirements, since the same criteria apply, regardless of the system involved. The provision allowing waivers to the public hearing requirements has been eliminated. These changes are intended to improve the ability of users to understand the regulation; strengthen VDOT's commitment to soliciting public input on its construction projects; and eliminate any loopholes to this underlying commitment. The OAG reviewed the proposed changes, and, by letter (copy attached) dated December 22, 2003, confirmed the following:

- that the APA exemption (§ 2.2-4002 B (3)) has been properly invoked;
- that VDOT has the authority under the cited statutes to amend the regulation as indicated, and
- that the amended regulation comports with applicable state laws.

By signature of the Acting Chief of Policy and Organizational Development on February 11, 2004, the Virginia Department of Transportation revised the regulation entitled "Public Hearings for the Location and Design of Highway Construction Projects" (24 VAC 30-380-10 et seq.).

The regulatory revisions have been made to consolidate the types of public hearings required for projects on the interstate, primary, urban, or secondary systems of state highways. This step improves the understandability of the requirements, since the same criteria apply, regardless of the system involved.
10	N/A	List of exclusions are shown in E 1 and 2 for which public hearings are not required or may be waived	Text is revised in E 1 to make the exemption more generally applicable to operational or maintenance projects without naming examples. This same revision also relocates existing conditions in 24 VAC 30-380-10 E 2 to 24 VAC 30-380-10 E 1under which otherwise exempted projects may be waived from a public hearing, to make a hearing explicitly required in the final text. These conditions include: the acquisition of additional right of way; the effects upon abutting real property; or changes to the layout or function of connecting roads or streets of the facility being improved. The final revision eliminates the provision in existing 24 VAC 30-380-10 E 2 under which waivers to public hearings can be sought, and renumbers 24 VAC 30-380-10 E 3 to 24 VAC 30-380-10 E 2 to accommodate the eliminated or relocated text.
