The Virginia Marine Resources Commission (VMRC) proposes to amend Chapter 4VAC20-1290-10 et seq., "Pertaining to Restrictions on the Harvest of Shellfish and in Condemned Shellfish Areas", to decrease regulatory burden and decrease the cost to the public of relaying shellfish.

Mandate and Impetus

[Mandate] VMRC is authorized by § 28.2-201 of the Code of Virginia to promulgate regulations and guidelines necessary to carry out the provisions of Title 28.2, including shellfish regulations.

[Impetus] Current regulations requires that individuals pay a \$150.00 daily fee for each relay permit that is issued by the Commission for the relaying of shellfish from condemned to open shellfish growing waters as classified by the Virginia Department of Health. The proposed regulatory change would require that the fee be paid only one time each calendar year. Individual permits would still be required but would be issued without additional cost to the permittee.
