The Virginia Marine Resources Commission (VMRC) proposes to amend Chapter 4VAC20-252-10 et seq., "Pertaining to Atlantic Striped Bass", to change management measures to comply with ASMFC Addendum II to Amendment 7 for striped bass, to change the recreational season for Potomac River tributaries summer/fall striped bass season, to streamline the aquaculture of striped bass process, and remove all gear restrictions for commercial harvesters that hold striped bass quota.

Mandate and Impetus

[Mandate] VMRC is authorized by § 28.2-201 of the Code of Virginia to promulgate regulations and quidelines necessary to carry out the provisions of Title 28.2.

[Impetus] January 24, 2024, the Atlantic States Marine Fisheries Commission (ASMFC) Atlantic Striped Bass Management Board voted to approve Addendum II to Amendment 7 to the Interstate Fisheries Management Plan (FMP) for Atlantic Striped Bass. The main goal of this Addendum is to reduce fishing mortality in the recreational and commercial striped bass fisheries. Addendum II implements a smaller recreational slot size limit for striped bass caught in the Chesapeake Bay and tributaries and decreases all commercial striped bass quotas by 7%. Addendum II will continue the recreational ocean slot size limit put into place during the 2023 emergency action. Jurisdictions must implement compliant measures as soon as possible and no later than May 1, 2024.

The Virginia recreational Potomac River tributaries summer/fall striped bass season is currently open from May 16 through December 31. The main stem of the Potomac River is managed by the Potomac River Fisheries Commission (PRFC) and closes the recreational striped bass season from July 7 through August 20. Closing Virginia's tributaries of the Potomac River from July 7 through August 20 will eliminate confusion for anglers and law enforcement on where it is legal and illegal to harvest and possess a striped bass.

All aquaculture requirements for raising and selling striped bass are currently outlined in the striped bass regulation. Removing this information from the regulation will streamline the process of receiving a striped bass aquaculture permit and more clearly explain the requirements for raising and selling striped bass. Removing these requirements will also reduce regulatory burden.

Currently, there are 5 approved gear types that commercial harvesters can use to catch striped bass when holding quota, gill net, pound net, haul seine, fyke net, or commercial hook-and-line. Commercial harvesters that hold striped bass quota do catch striped bass while targeting other species and using an unapproved gear type. Currently, any striped bass that is caught using an unapproved gear type is required to be released.
