During its 2017 session, the General Assembly enacted Chapter 594 of the Acts of Assembly which amended §§ 59.1-69, 59.1-70 and 59.1-74 of the Code of Virginia effective January 1, 2020. The Real Estate Appraiser Board is amending its regulations to conform to the statutory changes made as a result of these amendments. The regulations being amended (18 VAC 130-20-20 and 18 VAC 130-20-180) contain language which is no longer applicable as a result of the statutory changes. The amendments conform the relevant regulations to the amended Code of Virginia. The board is promulgating this regulatory action to conform the regulation to the law and there is no agency discretion pursuant to § 2.2-4006.A.4.a of the Code of Virginia.
