Final regulations were adopted by the Board for Branch Pilots at its meeting on July 29, 2011. The adopted regulations retain the same title as the existing regulations, "Board for Branch Pilots Regulations".

At its meeting in February 2009, the Board for Branch Pilots authorized staff to file a Notice of Intended Regulatory Action (NOIRA) for a general review to the Board's regulations including, but not limited to, review of the chemical testing regulations. At its meeting in October 2009, the Board for Branch Pilots approved proposed language. At its meeting in December 2009, the Board for Branch Pilots approved a Chemical Testing form. Final regulations were approved by the Board on July 29, 2011.

The Board is proposing changes to its existing regulations pertaining to the physical examination requirements for initial licensing and license renewal. The phrase is included to further clarify the Schedule of controlled substances. 18VAC45-Amended the initial licensing for a branch 20-10.B.5 pilot to include chemical testing in addition their physical examination. 18VAC Language added regarding limited branch pilot license renewal requirements to include 45-20chemical testing if not randomly performed 20.B.1 in previous 24 months. 18VAC45-Language added regarding full branch pilot 20-20.C.2 license renewal requirements to include chemical testing if not randomly performed in previous 24 months 18VAC45-Language added to include convictions 20-40.1 resulting from an arrest of any alcohol or drug-related offense. Language change regarding timeframe for 18VAC45-20-40.2 reporting offenses; language added to report alcohol or drug-related offenses. 18VAC45-Language change regarding timeframe for reporting any action by the National 20-40.3 Transportation Safety Board or the United States Coast Guard.

18VAC45- 20-40.9	Language change regarding timeframe for reporting physical or mental condition which may affect the ability to perform duties of a pilot.
18VAC45- 20-50.C.5	Language added to require the Medical Review Officer to report any delay or refusal by the licensee in reporting to test or being tested.
