Section 32.1-325 of the Code of Virginia authorizes the Board of Medical Assistance Services to administer and amend the State Plan for Medical Assistance and to promulgate regulations. Section 32.1-324 of the Code of Virginia authorizes the Director of the Department of Medical Assistance Services (DMAS) to administer and amend the State Plan for Medical Assistance and to promulgate regulations according to the

Board's requirements. The Medicaid authority as established by § 1902 (a) of the Social Security Act (42 USC § 1396a) provides governing authority for payments for services.

Alternatives

This periodic review focuses on the DMAS regulations related to the Uninsured Medical Catastrophe Fund (UMCF). The *Code of Virginia* (1950) amended, § 32.1-324.3, established the UMCF on the books of the Comptroller and authorized DMAS to promulgate regulations that (i) further define an uninsured medical catastrophe, (ii) establish procedures for distribution of moneys in the Fund to pay for the costs of treating uninsured medical catastrophes, (iii) establish application procedures, and (iv) establish criteria for eligibility for assistance from the Fund and the prioritization and allocation of available moneys among applicants for assistance from the Fund.

These regulations are essential because they implement the GA mandate. There are no viable alternatives for achieving the purpose of the regulations.

DMAS submitted its Notice of Periodic Review to the Town Hall on October 24, 2018. The comment period began on November 12, 2018 and ended on December 4, 2018. No public comments were received.

Effectiveness

The primary advantage of the UMCF is that some uninsured Virginians have medical treatments for medically catastrophic illnesses that they otherwise may not have been able to receive because they could not pay for it. The advantage to the agency and the Commonwealth is that these regulations will specify patient criteria, service coverage requirements and limitations, and reimbursement requirements necessary to administer these public funds. The regulations are necessary for the protection of public health, safety, and welfare in that they create the UMCF program. The regulations are clearly written and easily understandable.

Decision

DMAS is recommending no changes in these regulations as they remain essential and have no negative impacts.
