This periodic review focuses on the DMAS regulations related to public participation. The DMAS public participation regulations state that when formulating any regulation, the agency affords interested persons an opportunity to (i) submit data, views, and arguments, either orally or in writing, to the agency, to include an online public comment forum on the Virginia Regulatory Town Hall, or other specially designated subordinate and (ii) be accompanied by and represented by counsel or other representative.
