The regulation establishes standards for the safe, secure and humane transportation of pet animals and birds by carriers, dealers, exhibitors, pet shops, auction sales, cities, counties, animal control officers, pounds, and humane societies. The standards are for structure, space, ventilation, temperature and maintenance of primary enclosures (e.g., a room, pen, or cage used to immediately restrict an animal), primary conveyances (e.g., a motor vehicle, plane, ship or train used to convey an animal from origin to destination) and terminal facilities (e.g., a building, structure or grounds where animals will be loaded on or unloaded from a primary conveyance during transit) used in the transportation of animals. In addition, food and water, care, handling, and animal identification requirements are specified.

- 1. The protection of the public's welfare with the least possible cost and intrusiveness to the citizens and businesses of the Commonwealth.
- 2. To ensure the safe, secure and humane transportation of companion animals and birds by local animal control officers, humane societies, animal dealers and exhibitors.

Effectiveness of the regulation in achieving such goals: The Virginia Department of Agriculture and Consumer Services has noted a decline in the number of complaints involving the transportation of companion animals since the regulation was promulgated in 1987. It is believed that the reduction in the number of complaints indicates compliance with the requirements of the regulation by an increasing number of the individuals and entities involved in the transportation of such animals.

The regulation protects the public's welfare by setting minimum enforceable standards for the proper transportation of companion animals and birds to ensure the health of citizens' animals being transported by animal control officers, humane societies and animal dealers. Such standards also ensure that citizens' pets are not injured or lost during transit. The standards also protect citizens from economic loss by protecting their pet during transit. An added benefit is the psychological welfare of citizens who are assured that their pets (to which the owners often have strong emotional bonds) are being treated, handled, and cared for humanely during transit.

The regulation helps ensure family stability and the family institution by minimizing both economic and emotional losses to families that have strong attachments to their pet animals and who would have to face the loss of such a pet if injured or lost during transit.

The regulation is clearly written and easily understandable by individuals and entities affected.

#### **Alternatives**

The alternative would be to eliminate the regulation. This alternative was rejected because, for over a decade prior to enactment of this regulation, localities, private organizations and the public had attempted to effectively deal with the isssues involving the transportation of pet animals and birds. This regulation has successfully resolved most of the problems because the processes and requirements of the regulation have proven to be effective and efficient, and have shown to be the least intrusive and least burdensome mechanism for localities and the general public in dealing with the transportation of pets.
