## Legal basis

The Department of Mines, Minerals and Energy (DMME) has authority to promulgate this regulation under authority found in § 45.1-161.3, Powers of the Department, § 45.1-230, Authority and duties of Director, and § 45.1-261.1, Operators may perform reclamation.

- Section 45.1-161.3 empowers DMME, with the approval of the Director, to promulgate regulations necessary or incidental to the performance of duties or execution of powers under Title 45.1 of the Code of Virginia.
- Section 45.1-230 of the Code of Virginia empowers the DMME Director to promulgate regulations as may be necessary to carry out the provisions of the Virginia Coal Surface Mining Control and Reclamation Act, chapter 19 of Title 45.1 of the Code.
- Section 45.1-261.1 of the Code of Virginia provides the required findings that the Director shall make in determining whether an operator is eligible to bid on contracts to conduct reclamation projects under the State Reclamation Program and Title IV of the federal Surface Mining Control and Reclamation Act of 1977 (30 USC 1235).

### Alternatives

The Department considered the alternative of repealing the regulation, but determined that the regulation is still needed to protect public safety, health, and welfare.
