    - of **Jails** i. **Motion** The Board Local and Regional (APPROVES/DISAPPROVES) the Portsmouth City Jail's request for state funding for the Renovation and Upgrades in their facility. This motion recognizes a total eligible cost of \$105,683,776 of which up to 25% or \$26,420,944 would be eligible for State reimbursement in a lump sum payment. Such reimbursement is subject to the availability of funds and compliance with Board Standards for Planning, Design, Construction and Reimbursement of Local Correctional Facilities, 2018, and Sections 53.1-80 through 82 of the Code of Virginia.
  - b. Pittsylvania County Jail Construction Project (presentation by Moseley Architects)
    - i. Motion The Board of Local and Regional Jails (APPROVES/DISAPPROVES) the Pittsylvania County Jail's request for state funding for the Construction of their new facility. This motion recognizes a total eligible cost of \$60,307,012 of which up to 25% or \$15,076,753 would be eligible for State reimbursement in a lump sum payment. Such reimbursement is subject to the availability of funds and compliance with Board Standards for Planning, Design, Construction and Reimbursement of Local Correctional Facilities, 2018, and Sections 53.1-80 through 82 of the Code of Virginia.

- c. Prince William Manassas Regional Adult Detention Center Renovation and Upgrade Project
  - i. **Motion** The Board of Local and Regional **Jails** (APPROVES/DISAPPROVES) the Prince William – Manassas Regional Adult Detention Center's request for state funding for the Renovation and Upgrades in their facility. This motion recognizes a total eligible cost of \$2,165,000 of which up to 25% or \$541,250 would be eligible for State reimbursement in a lump sum payment. Such reimbursement is subject to the availability of funds and compliance with Board Standards for Planning, Design, Construction and Reimbursement of Local Correctional Facilities, 2018, and Sections 53.1-80 through 82 of the Code of Virginia.
- d. Montgomery County Jail Vehicle Sallyport Addition
  - Local i. Motion The Board of and Regional Jails (APPROVES/DISAPPROVES) the Montgomery County Jail's request for state funding for the Vehicle Sallyport Addition to their facility. This motion recognizes a total eligible cost of \$884,206 of which up to 25% or \$221,051 would be eligible for State reimbursement in a lump sum payment. Such reimbursement is subject to the availability of funds and compliance with Board Standards for Planning, Design, Construction and Reimbursement of Local Correctional Facilities, 2018, and Sections 53.1-80 through 82 of the Code of Virginia.
