A vote was taken on Mr. Schwartz' motion for a 90 day delay, the motion failed with ten (10) nay's (Mr. Koelemay, Dr. Davis, Mr. Dickens, Mr. Martin, Mr. McCarthy, Mr. Bowie, Mrs. Connally, Mr. Davies, Mr. White and Mr. Keen) and two yea's (Mr. Schwartz, Mr. Sterling).

The original motion was then presented for action having been moved and seconded, the motion passed with 11 yeas (Mr. Sterling, Mr. Koelemay, Dr. Davis, Mr. Martin, Mr. McCarthy, Mr. Bowie, Mrs. Connally, Mr. Davis, Mr. White, Mr. Keen and Mr. Dickens) and one nay (Mr. Schwartz). The motion passed.
