Meeting Minutes

Nonhazardous Solid Waste Fee Study Working Group DEQ Central Office, Third Floor Conference Room 1111 East Main Street, Richmond, Virginia Wednesday, September 22, 2021

The meeting convened at 10:05 a.m. The meeting adjourned at 2:18 p.m. A quorum of the working group members (or their alternates) was not present for this meeting.

- Welcome and Introductions [Angie Jenkins, DEQ]. Ms. Jenkins welcomed the members and the other attendees, had the members and attendees introduce themselves, reviewed the FOIA public meeting requirements, and reviewed the general building logistics. The agenda for the meeting had been previously emailed to members (Attachment 1). Minutes for the previous meeting of the work group had been posted to the Virginia Regulatory Town Hall before the meeting.

- 2. Program Information [Kathryn Perszyk, DEQ]. Ms. Perszyk presented information requested by members at the last meeting.
- 3. Group Discussion [Angie Jenkins, DEQ]. Members expressed some ideas for further discussion based upon the presentation:
 - a. Ms. Jenkins noted that a quorum of the working group members are not present at this meeting, so while information can be presented and discussed at this meeting, no decisions can be made. However, members may propose changes to the fee structure for consideration by the working group at the next meeting.
 - b. Members suggested that additional, more detailed timecard tasks would be helpful in the future so that a more detailed workload analysis can be done to support future program fee adjustments (recognizing such a system is not currently available).

- c. Members suggested a number of ideas to be tested for consensus at the next meeting:
 - i. Since the cost of living since 2004 (according to the Department of Labor BLS Consumer Price Index) has increased approximately 32%, the permit fees should be increased by approximately 32% with some exceptions based on the groups' discussion regarding workload, etc. (e.g. variance requests and PBR fees). The group also suggested rounding of numbers. DEQ was asked to provide a spreadsheet reflecting the changes to permit application fees discussed during this meeting.
 - ii. Consistent with this approach, increase applications for new landfills: Part A to about \$5,500; Part B to about \$25,000 and Emergency permits to about \$3000
 - iii. Increase variance request application fees from \$390 to \$750.
 - iv. Increase PBR application fees up to \$1500 for the initial application and to \$750 for each modification application.
 - v. Add a new \$750 application fee for permit minor modifications.
 - vi. Add a minimum \$750 application fee for major permit modifications, increase the other categories by approximately 32%, and add an additional fee amount for each module in the permit changed.
 - vii. Change post-closure facility annual fees to a base fee plus a fee for each corrective action (e.g. a base fee of \$3500 plus \$4000 for each corrective action).
 - viii. For facilities paying \$/ton annual fees, impose a minimum base fee (perhaps on a sliding scale for larger facilities) and then adjust the \$/ton fee.
- 4. Next Steps (Angie Jenkins, DEQ).
 - a. Send the following spreadsheets to members:
 - i. Annual Fee Spreadsheet (Attachment 2), and
 - ii. Permit Application Fee Adjustment Spreadsheet based on the group discussion (listed above) for consideration by the full group during the next meeting (Attachment 3).
 - b. The next meeting will be on Friday, October 22, 2021 providing that a poll of members indicates that a quorum of the members will be present.
