Meeting was called to order by Chair, Mrs. Brown at 10:07 a.m.

ORDER OF BUSINESS

Motion made by Mr. Slater to approve the order of business noting the removal ALB-1372 Request for Review from the agenda; motion seconded Mrs. Baskerville and was passed unanimously.

PUBLIC COMMENTS

Mr. John Burke, attorney, spoke on behalf of his clients, Trigg and Carrington Brown. He shared his concerns regarding a request for internal boundary line adjustments on an easement property that is currently owned by several different owners. Mr. Armistead, one of the owners, has made the request for adjustments on the easement property, located in Bath County. Mr. Burke urges Virginia Outdoors Foundation to uphold the easement as it stands.

PUBLIC COMMENTS

Rex Linville urged the trustees to not broaden the interpretation of easements to include industrial sized solar farms that provide electricity to places other than the easement property itself. He also informed us of workshops taking place May 10th, 16th and 22nd promoting land conservation.

Motion made by Mr. Slater to adjust the order of business and move the Chair's and Executive Director's report after the International Consulting Services presentation; motion seconded by Mrs. Baskerville and passed unanimously.

STRATEGIC PLAN PROCESS PRESENTATION

International Consulting Services has been hired to facilitate a Strategic Plan for Virginia Outdoors Foundation and they presented an outline for the process. That presentation is on file with the permanent record of this meeting.

CHAIR'S REPORT

Mrs. Brown thanked Brett and other trustees for the help provided in maintaining our budget line amount by calling and writing our legislators. She spoke of the Governor's plans for an increase to 2% of the fiscal year budget to be spent on natural resources and the idea of being more strategic and targeted in our land conservation efforts. Secretary Strickler will be at our June 21st meeting. First Lady Pam Northam will be attending a trout release on the VOF owned Bull Run Mountains Natural Area Preserve on May 10^{th.}, VOF has been invited to a Governor's event at Malvern Hill on May 15th and VOF recorded its first easement in the city of Richmond.

Brett's report – EnRichmond Foundation is the recipient of AmeriCorps NCCC Southern Region **Sponsor of the Year** for Class XXIV. The work at Evergreen has brought a lot of attention to the preservation needs of other cemeteries. A project for PTF funding the Tucker Family cemetery in Hampton VA, is on this agenda for the Board to review. Hampton is taking a leadership role with the approaching 2019 400- year anniversary of people being brought to America from Africa to enslave them. VOF was well represented at the recent VaULT conference. Brett also introduced Emily Nelson White the Program Manager for the new grant program.

Jason Bulluck, Director of Natural Heritage presentation named the Assessing Impacts of Large Development Projects on Virginia's Remaining Core Forests is on file with permanent record of this meeting

REMINGTON - GORDONSVILLE TRANSMISSION LINE EXPANDED RIGHT OF WAY REQUEST

Greg Matthew of Dominion Energy presented Remington-Gordonsville 230 KV Double-Circuit Transmission Line outlining the process, the need and the choices of kinds, height and width of towers. This presentation is on file with the permanent record of this meeting.

Attorney Mr. Hudson representing multiple easement owner John Sheldon Clark urged the trustees to grant the request for expanded right of way.

VOF's Brian Fuller facilitated a presentation which is on file with the permanent record of this meeting.

Motion made by Mr. Slater to approve the applications before us on 12 open-space easements in Orange County to grant additional right of way for the rebuilding and upgrading of the Remington-Gordonsville 230kV electric transmission line upon the voluntary agreement of the landowner, based on the background information and including the conditions provided in the May 3, 2018 Staff Report; motion seconded by Mrs. Baskerville and approved unanimously.

WYT-03795 REQUEST FOR REVIEW

Harry Hibbitts brought us through a presentation outlining a request for a 65,000 sq. ft. barn. The presentation is on file with the permanent record of this meeting. Motion made by Mr. Slater to approve this request including all the stipulations included in the recommendations in the meeting materials; motion seconded by Ms. Obenshain and passed unanimously.

RESOLUTION BY THE VIRGINIA OUTDOORS FOUNDATION BOARD OF TRUSTEES TO AUTHORIZE SALE OF CERTAIN PARCEL OF LAND

WHEREAS, the Virginia Outdoors Foundation (VOF) owns certain parcels of land that were donated with the clear intention, or ability, for the parcels to be sold and proceeds to benefit further conservation work; and

WHEREAS, the one lot in White House Creek Estates, Lancaster County (Coll/Ingram Gift), has been listed for sale since 2015; and

WHEREAS, the Virginia Outdoors Foundation passed a resolution in 2011 authorizing the sale of this parcel with proceeds to be used at its Kohl's Island property, a parcel of high conservation value that has management needs that could be funded by proceeds from the sale; and

WHEREAS, the Board of Trustees has adopted procedures regarding the sale of land both with respect to appraisals and to sale methods;

WHEREAS, in 2014 the Board of Trustees authorized staff to proceed with sale of any "sale parcels" that met the following two conditions. 1.) the offer being at least 90% of list price and 2.) the appraised value of parcel does not exceed \$50,000; and

WHEREAS, staff recommends that VOF accept the contract dated March 27, 2018 for the White Creek Estates lot; and now, therefore, be it

RESOLVED by the Virginia Outdoors Foundation Board of Trustees this 3rd day of May 2018, That staff be authorized to sell the White House Creek Estates lot and accept offer and terms contained in contract offer.

RESOLUTION VIRGINIA OUTDOORS FOUNDATION (VOF) BOARD OF TRUSTEES RESOLUTION REGARDING HOUSE MOUNTAIN

WHEREAS, Virginia Outdoors Foundation is the owner of the House Mountain Reserve (hereafter, "the Reserve"), a tract of land located in Rockbridge County northwest of Lexington; and

WHEREAS, Chapter 525 of the Acts of 1966, Chapter 18, Title 10.1, Sections 10.1-1800 through 10.1-1804 of the Code of Virginia (hereafter, "VOF's Enabling Statute"), declares it to be the public policy of the Commonwealth to encourage preservation of open-space land and authorizes the VOF to hold real property or any estate or interest therein for the purpose of preserving the natural, scenic, historic, scientific, open-space and recreational lands of the Commonwealth; and

WHEREAS, as owner and manager of House Mountain, VOF has ongoing responsibilities to care for the property in the best interests of conservation and the Commonwealth; and, now therefore, be it

RESOLVED, by the VOF Board of Trustees, this 3rd day of May 2018, that the following is approved and adopted:

VOF staff is authorized to undertake routine management activities on the Reserve, shall continue to provide regular reports to the Board of Trustees and seek Board input and approval for any substantial decisions related to the Reserve. General principles guiding staff work and management of the Reserve shall be:

- Any activities at the Reserve shall be consistent with VOF's Enabling Statute, specifically to
 protect the natural, scenic, historic, scientific, open-space and recreational features of the
 Reserve;
- Any decisions shall be driven by what is in the best conservation interests of the Reserve;
- Staff shall seek input from the Rockbridge community and local government such as, but not limited to, the Rockbridge County Board of Supervisors, Office of Community Development, VMI, W & L, and neighboring property owners, as appropriate;
- VOF shall not conduct or permit any commercial timbering on the Reserve. Additionally, VOF shall not cut any trees on the Reserve until a formal management plan is adopted except under the following circumstances:
 - o for maintenance of existing roads, trails, structures and the meadow in saddle area; and
 - to remove trees which pose a threat to the health or safety of the public, the Reserve or neighboring properties.
- VOF shall create and implement a formal management plan for the Reserve and such
 management plan must be reviewed and approved by the Board of Trustees prior to adoption.
 Staff shall seek input from the Rockbridge community and local government while developing
 this plan.
