The Chair, Eleanor Brown convened the meeting at 1:00 p.m. and welcomed everyone to the virtual meeting and reading the following statement:

"This meeting is proceeding under Item 4-0.01, subsection G of the Appropriation Act and section 2.2-3708.2 of the Code of Virginia. It is being held by electronic communication, as the COVID-19 virus has made a physical meeting of the Board impracticable. This emergency imposed by COVID-19 is observed by Executive Orders 51, 53, and 55 issued by the Governor of Virginia. The Board's actions today shall be limited to those matters included on the agenda. All of these proposed actions on this agenda are statutorily required or necessary to continue operations and discharge lawful purposes, duties, and responsibilities of the Board. **Reminders**: This meeting is being recorded, which recording will be made available to the public as required by Appropriation Act section cited above. To get a good record, we will do a roll call votes today for all board action items. Bobbie will conduct the roll call votes. And, lastly since this is being recorded, please be mindful to not speak over one another during our discussions. "

Eleanor asked that Bobbie Cabibbo call the roll and the attendees are listed above.

Approval of the Order of Business

Tom Slater made the motion to approve the Order of Business; motion seconded by Steph Ridder and passed unanimously with a roll of 7 ayes and 0 nays.

Public Comments

Jane Meyers of Capital Region Land Conservancy submitted a question via the VOF website asking about whether a riparian protection provision was being placed on the proposed Richmond City project. Leslie Grayson explained that the entire property will function as a riparian protection zone once the easement is in place. It was noted that Jason Bullock (DCR) was available for any questions concerning the request for addition funds in the Poor Mountain project.

Chairs Report/Comments

Eleanor reported and commented on the following topics:

- Thanked the staff for the good work on the 30 projects to be presented today.
- The General Assembly session was very productive with both bills HB1622 and HB1623 passing. Thank you to Delegate Plum for sponsoring both bills and to everyone that worked hard with phone calls and other means of support for those bills. Eleanor extended special thanks to Ellen Shepherd from VaULT and VOF Trustee, Viola Baskerville. Viola brought her skills and experience to the effort and taught us all how to get it done.
- Thanked the staff for the extraordinary effort during this trying time of COVID-19, working at home but continuing the important work of land conservation. These times have highlighted how important it is to cherish our open space and reconnect with the outdoors.
- She reserved time at the end of the meeting to discuss current events

Executive Director's Report/Comment

Brett Glymph report and commented on the following:

- Thanked Viola Baskerville for the help on the legislative package calling her the "difference maker", guiding us through the process to a successful conclusion where in the past we have not been as successful.
- HB1622 was an amendment to expand our grant making capability with the Preservation Trust Fund grants and it passed.
- HB1623 increased our recordation fee to \$3.00 per deed and Brett thanked Jason McGarvey and Nikki Rovner in addition to those already thanked. This bill also passed.
- Eleanor and she met with Senator Deeds who sponsored legislation to transfer ownership of Hayfields to DCR. We respectfully requested that VOF have a meaningful part of the decision and planning process. Senator Deeds received these requests favorably and the legislation was amended to ask for a study of that proposed action. The study's presentation to the Senate was delayed until 2021 because of COVID=19.
- Staff worked hard on many projects even with the stay at home orders, and now that Virginia is in Phase 2, we have resumed in person easement monitoring. VOF has provided some personal protection equipment, amended use of personal car procedures and reimbursements so that there is no sharing of vehicles.
- General Assembly meets again in August to deliberate changes to the budget as result of reduced revenue receipts due to COVID-19. Already, the \$10,000,000 funding proposed for Virginia Land Conservation Fund has been reduced and VOF PTF portion reduced to \$1.25 million for PTF grants. The August session could result in further reductions or other budget cuts that will affect VOF operations.
- Both VaULT and Rally conferences will be online later this summer and fall, if any trustee is interested in attending please let us know.
- Recognition of the retirement of Tamara Vance, who worked at VOF since 1995. Staff looks forward to celebrating her retirement and Beth has offered to host that gathering when safe.

Approval of Minutes

Motion Made by Tom Slater to approve the draft minutes of the 9/25/2020 Board of Trustees meeting; motion seconded by Steph Ridder and it passed unanimously with a roll called vote of 7 ayes and 0 nays.

Motion made by Steph Ridder to approve the draft minutes of the 5/21/2020 Finance, Audit and Compliance Committee meeting; motion seconded by Viola Baskerville and passed unanimously with a roll called vote of 7 ayes and 0 nays.

Budget FY21

Anna Chisholm called for questions about what was included in the meeting materials. She sited that there may be additional cuts and it was a hard budget to predict. Some expenditures have been put on hold until incomed is more predictable. Brent congratulated us on the recordation fee increase because it is very important at times like these. Motion made by Tom Slater to pass the FY21 Budget and resolution presented in the meeting materials; motion seconded by Viola Baskerville and it passed unanimously with a roll called vote of 7 ayes and 0 nays. TerraTrac Demo

Dave Morton narrated a presentation on the new project tracking system that has been in development since 2015. The presentation is on file with the permanent record of this meeting as well as the video/audio recording.

Stewardship Report

Martha Little commended her staff for their monitoring efforts, despite limits on travel. The monitoring was accomplished by using high resolution remote aerial analysis. This project was led by Brad Baskette and the imagery was available for south western Virginia.

Forest CORE

Emily White briefly described the proposed a. changes to the program, b. the proposed upcoming grant round and the request for additional funds for the Poor Mountain project. Viola invited Emily to brainstorm with her to expand awareness of the grant program. Tom asked Emily to make a concerted effort to reach out to the Appalachian Trail Conservancy as this grant would allow for trail maintenance. Motion made by Beth Obenshain to:

- approve an additional \$62,504 for the DCR-Poor Mountain Greenways Connector project, funded through the Forest CORE Fund in 2018 for \$500,000. The request was due to increased costs resulting from higher appraisal value than estimated and challenging on the ground conditions for site work.
- approve the Community-Supported Conservation Program Update to the Forest CORE Fund including the following material: Fact Sheet, Manual and appendices, Application, Budget Request Form, Scoring Sheet3; and
- Approve \$1,000,000.00 for the 2020 Community-Supported Conservation grant round, with the option for the Board to approve more/less (within a certain amount) if the quality of applications necessitates such action.

Motion seconded by Viola Baskerville and passed unanimously with a roll call vote of 7 ayes and 0 nays.

Owned Lands

Leslie Grayson did a short review of the meeting materials highlighting that House Mountain has remained open to the public these past few months and that Bull Run Mountains Natural Area Preserve did close for a period and reopened the June 19th. Leslie reviewed the resolution to sell the Ski Lodge Parcels. Motion made by Steph Ridder to approve resolution allowing the sale of the parcel; motion seconded by Brent Thompson and passed unanimously with a roll call vote of 7 ayes and 0 nays. Hayfields Report Review

Martha Little called for questions on the report in the meeting materials. Brent inquired about property maintenance and Martha outlined the plan currently in place. All members of the board were in agreement that a trip to the property is warranted when the time is appropriate.

RESOLUTION VIRGINIA OUTDOORS FOUNDATION BOARD OF TRUSTEES AUTHORIZE SALE OF RAPPAHANNOCK COUNTY LAND

WHEREAS, the Virginia Outdoors Foundation (VOF) owns certain parcels of land that were donated with the clear intention, or ability, for the parcels to be sold and proceeds to benefit further conservation work; and

WHEREAS, the lots known as the Old Ski Lodge parcel in Rappahannock County (Jones Gift), was donated in August 2017; and

WHEREAS, the Virginia Outdoors Foundation passed a resolution in December 2018 authorizing the listing of this parcel and approving the terms of open space easement to be retained by VOF in order to protect its conservation values; and

WHEREAS, the property has been listed for sale since early 2019, the list price has been reduced twice, and several offers have been received though none met the advertised price; and

WHEREAS, staff recommends that VOF Board of Trustees authorize staff to accept a contract for the Ski Lodge parcel provided that the offer:

1. meets the price communicated to the Trustees prior to this meeting, and

- 2. the buyer accepts all terms of the approved open space easement with the amendment of an increase in the permitted house size from 1,600 square feet to 1,800 square feet, and
- 3. staff is satisfied with the financing and there are no unusual burdensome contingencies contained in the contract; and now, therefore, beit

RESOLVED by the Virginia Outdoors Foundation Board of Trustees this 25th day of June 2020, that staffbe authorized to sell the Ski Lodge parcel subject to the terms described above.

FURTHER RESOLVED that both the Executive Director and the Deputy Director of Policy and Acquisitions are each individually duly authorized to execute and deliver all appropriate and necessary documents and take all other actions necessary on behalf of the Virginia Outdoors Foundation to effectuate said sale.
