Ms. Roukous reported that the Committee found that while providing treatment to Patient A, Dr. Banes failed to document a diagnosis in the treatment record to justify the need to place a crown on tooth #30 and a filling in tooth #31, and to document the material used to cement the temporary crown on tooth #30.

The Committee also found that radiographs taken on February 1, 2012 and July 10, 2012, showed that Dr. Banes failed to address the periodontal defect and inflammation associated with Patient A's tooth #31; placed a crown on Patient A's tooth #30 that had an improper contour and open margins, and that invaded the biological width of space; and also placed a restoration on Patient A's tooth #31 that was poorly contoured and allowed for food to become trapped in the area.

The sanction reported by Ms. Roukous was that Dr. Banes shall pay a \$1,000.00 monetary penalty.

Dr. Rizkalla moved to adopt the decision of the Committee. The motion was seconded and passed.


