**AGENDA:** Mr. Boehm requested that the agenda be revised to

and carried unanimously.

**PUBLIC COMMENT:** No public comment was presented.

## APPROVAL OF MINUTES:

Mr. Howell moved to approve the full board's February 3, 2009 meeting. The motion was seconded and carried unanimously.

Mr. Howell moved to approve the New Board Member Training minutes of the December 17, 2008 meeting. The motion was seconded and carried unanimously.

## DEPARTMENT DIRECTOR'S REPORT:

Dr. Carter provided the Board members with copies of Ms. Ryals' May 6, 2009 press release and Frequently Asked Questions. Ms. Cooper expressed concern regarding the issue of the security breach and information being available in the news media prior to disclosure to the Board members. Mr. Boehm suggested that the Education Committee review the issue of how best to inform Board members and licensees about urgent matters in the future.

**VA Performs** - Dr. Carter reported that Ms. Ryals would be providing a formal report soon. She noted, however, that the news on the agency's performance would be good.

Workforce Center – Dr. Carter apprised the Board on the progress of the Healthcare Workforce Center which is headed by Ms. Beverly Beck. She noted that they had been making significant progress toward determining core survey questions to enable an ongoing, and most importantly, validated database of information pertaining specifically to Virginia's health profession workforce. A formal report on the Center's progress, to date, will be published this summer.

# LEGISLATIVE/REGULATORY UPDATE:

Ms. Yeatts presented an overview of the 2009 legislation that may impact the agency and/or the respective boards. Specifically, she noted Dentistry's emergency regulations requiring the registration of mobile dental clinics and the licensure of radiological technologists. A copy of the proposed 2009 legislation summary is incorporated into the minutes as Attachment 1.

Ms. Yeatts also informed the Board of the required due dates for the 2010 proposed legislation.

# EXECUTIVE DIRECTOR'S REPORT:

Dr. Carter apprised the Board that its budget remains solvent. She also reported that Justin Crow will remain as the Board's Research Assistant through December 2009. Further, she reported that Neal Kauder, of Visual Research, Inc., is completing the Sanctions Reference point systems research for the Boards of Audiology and

Speech-Language Pathology, Long-Term Care, and Physical Therapy. A formal report on the evaluation of the Sanctions Reference efficacy is planned for the Fall. Additionally, Mr. Kauder has been conducting research for the agency into how patient care versus non-patient care cases should be optimally classified and tracked.

# REGULATORY REVIEW COMMITTEE REPORT:

Mr. Howell presented a report of the Committee's actions on the study of Emerging Professions. The Committee's recommendations are listed as follows:

Orthotists and Prosthetists – The Committee recommended that the professions not be regulated and the motion of the Committee was seconded by Ms. Hughes and carried unanimously.

Medical Interpreters – The Committee requested that staff contact the Department of Health and the Department of Medical Assistance Services to seek their input regarding the state's oversight of the profession.

**Polysomnographers** – The Committee requested that Mr. Crow present his presentation to the Respiratory Therapy Advisory Committee for their review and recommendation back to the Board.

Surgical Assistants and Surgical Technologists – The Committee requested a public hearing for additional public comment prior to rendering a recommendation to the full Board.

**BOARD REPORTS:** 

Mr. Howell reported that the Board of Physical Therapy had requested a guidance document regarding licensees who hold dual licenses or certification resulting in the overlapping of scope of practice. He stated that the Board was seeking guidance and solutions in regards to crossover of scope of practice and regulations. Dr. Chadwick shared some of the experiences of the Board of Audiology and Speech-Language Pathology. Dr. Argow, Mr. Boehm and Dr. Stuts also spoke to the issue of multiple certifications within and across the behavioral science boards. Additionally, Dr. Carter indicated that when complaints are lodged against multiple license/certificate holders of differing boards, the case is referred to each board under which the a respondent holds a license/certificate. Depending upon the particulars of the case, if founded, one or each board may take action, depending upon the applicable regulation.

Mr. Boehm apprised the Board of the Board of Social Work's study relating to the exempt status of persons working as social workers in state settings pursuant to HB1146 (2006). Further, he requested the Board's approval to assign the matter to the Regulatory Research Committee for its input and recommendations. Mr. Howell moved to approve the request. The motion was seconded and carried with Mr. Boehm abstaining.

**NEW BUSINESS:** No new business was presented.

**ADJOURNMENT:** Mr. Howell moved to adjourn the meeting at 2:05 p.m.

The motion was seconded and carried unanimously.

## Report of 2009 General Assembly

## HB 1601 Administration of prescription drugs; expands authority of persons allowed to administer.

## Summary as introduced:

Administration of prescription drugs. Expands authority of persons who have completed a training course approved by the Board of Nursing, and who do so in compliance with the prescriber's instructions and in accordance with regulations promulgated by the Board of Pharmacy, to allow administration of prescription drugs where the drugs would normally be selfadminister by an individual receiving services in a program licensed by the Department of Mental Health, Mental Retardation, and Substance Abuse Services. Such authority was previously limited to administration of drugs that would normally be selfadministered by a resident of a facility licensed or certified by the Department of Mental Health, Mental Retardation and Substance Abuse Services.

## HB 1744 Natural health care providers; not licensed may provide care to consumer for use of natural foods.

## Summary as introduced:

Health professions; natural health care providers. Clarifies that an individual who is not licensed, registered, certified, or permitted by a health regulatory board may provide health care services, therapies, and methods by assessing, evaluating, advising, educating, counseling, informing, or rendering care to consumers regarding the use of natural foods, dietary supplements, homeopathic remedies and products, and healing and natural therapies for the prevention, remedy, or treatment of various health or physical conditions as long as he discloses to consumers his qualifications and does not violate existing provisions governing the health professions.

## HB 1812 Questioning employees about criminal convictions; prohibits employer from asking about certain.

## Summary as introduced:

Questioning employees about criminal convictions; penalty. Prohibits a state agency employer from asking an existing or prospective employee about the individual's record of arrests or convictions, unless the question refers to an arrest or conviction that occurred within the preceding eight years or was for a violent felony. An employer may not take negative employment actions against an individual based on a response to a prohibited question. A violation is punishable by a \$500

### civil penalty.

## HB 1820 Naturopathy; establishes licensure requirements for practice thereof.

#### Summary as introduced:

Practice of naturopathy. Establishes licensure requirements for the practice of naturopathy. This bill establishes criteria for the practice of naturopathy, including educational requirements, examinations, scope of practice, requirements for the promulgation of regulations governing the profession, and an advisory board to the Board of Medicine.

Clarifies that confidentiality provisions do not prevent Department of Health Professions' investigators from (i) providing the subject of a complaint with a copy of the complaint and supporting documentation or (ii) interviewing witnesses and disclosing to them information necessary to conduct the investigation.

## HB 1909 Funerals and burials; designation of persons authorized to make decisions.

#### Summary as introduced:

Designation of persons authorized to make funeral and burial decisions. Designates the persons in order of priority who have the ability to make all necessary arrangements for a decedent's funeral and the disposition of his remains. This bill is in response to recent cases in Virginia concerning who had the right to make such decisions. Current law allows any next of kin to make arrangements, without specifying an order of priority. This bill grants funeral services providers civil immunity for decisions made if there is a dispute among members of the same class, in the absence of bad faith. The bill contains technical

### HB 1939 Radiologist assistants; licensure.

## Summary as introduced:

Radiologist assistants; licensure. Provides for the licensure of radiologist assistants as individuals who have met the requirements of the Board of Medicine for licensure as advanced-level radiologic technologists and who, under the direct supervision of a licensed doctor of medicine or osteopathy specializing in the field of radiology, are authorized to (i) assess and evaluate the physiological and psychological responsiveness of patients undergoing radiologic procedures; (ii) evaluate image quality, make initial observations, and communicate observations to the supervising radiologist; (iii) administer contrast media or other medications prescribed by the supervising radiologist; and (iv) perform, or assist the supervising radiologist to perform, any other procedure consistent with the guidelines adopted by the American College of Radiology, the American Society of Radiologic Technologists, and the American Registry of Radiologic Technologists.

## HB 1943 Optometrists; those licensed may sell contact lenses & allowed to dispense ophthalmic devices.

#### Summary as introduced:

Optometrists; contact lenses and ophthalmic devices. Specifies that only licensed optometrists and ophthalmologists, or licensed opticians with a contact lens endorsement may sell contact lenses, and allows licensed optometrists and ophthalmologists to dispense ophthalmic devices that contain medication.

## HB 1984 Physicians and patients; eliminates limiting patient's health information introduced at trial.

## Summary as introduced:

Communication between physicians and patients. Eliminates requirement limiting patient's health information that may be

discovered or introduced at trial to information obtained or formulated during treatment and contemporaneously recorded by the treating health practitioner.

## HB 2058 Dentistry, Board of; recovering monitoring costs.

## Summary as introduced:

Board of Dentistry; recovering monitoring costs. Allows the Board of Dentistry to recover from any licensee against whom disciplinary action has been imposed reasonable administrative costs associated with investigating and monitoring such licensee and confirming compliance with any terms and conditions imposed upon the licensee as set forth in the order imposing disciplinary action. Such recovery shall not exceed a total of \$5,000.

Allows the Board of Pharmacy to register an animal shelter or pound to purchase, possess, and administer certain Schedule II-VI controlled substances approved by the State Veterinarian for the purpose of euthanizing injured, sick, homeless, and unwanted domestic pets and animals; and to purchase, possess, and administer certain Schedule VI controlled substances for the purpose of preventing, controlling, and treating certain communicable diseases that failure to control would result in transmission to the animal population in the shelter or

Provides that regulations governing the practice of midwifery shall require midwives to disclose to their patients information on health risks associated with home deliveries including but not limited to special risks associated with vaginal birth after a prior C-section, breach births, births by women experiencing high-risk pregnancies, and births of twins or multiples.

Removes requirement that a prescriber obtain written consent from the recipient of a prescription before requesting information on that recipient for the purpose of establishing his treatment history. However, requires that notice be given to patients that information may be requested by the prescriber from the Prescription Monitoring Program.

## Summary as introduced:

Tracking of ephedrine and pseudoephedrine; pilot program. Requires the Board of Pharmacy, in conjunction with local law-enforcement officials, to establish a mandatory pilot program in the Counties of Page, Clarke, Frederick, Rockingham, Shenandoah, and Warren to implement an electronic recordkeeping system of the transactions involving the distribution of ephedrine and pseudoephedrine as required by state law. This bill is contingent upon funds being provided by a third party or agency, such that there will be no cost to participating pharmacies.

## HB 2396 Advance medical directives; revises Health Care Decisions Act to clarify process.

#### Summary as introduced:

Advance medical directives. Revises the Health Care Decisions Act to (i) clarify the process for determining a patient to be incapable of making an informed decision regarding health care; (ii) require that determinations of incapacity be made by two physicians, or one physician and one licensed clinical psychologist, one of whom is not otherwise involved in the care of the

patient; (iii) allow any one physician to declare that a patient is again capable of making an informed decision; (iv) clarify the authority of an agent named in an advance directive, or a person otherwise given authority to make medical decisions for an incompetent patient; and (v) determine when a physician may treat a patient over his protests.

Expands the requirement to submit certain information to the Department of Health Professions to anyone licensed, certified, registered, or holding a multistate licensure privilege issued by a health regulatory board. Also allows the Department, and the Board of Nursing, to release any information for the purpose of bona fide research or education to qualified personnel, provided data elements that could reasonably identify a specific individual shall be deleted or redacted from such information prior to disclosure. Further, the release of such information shall only be made pursuant to a written agreement,

## HB 2407 Health Practitioners' Intervention Program; revisions, changes name.

### Summary as introduced:

Health Practitioners' Intervention Program; revisions. Changes the name of the Health Practitioners' Intervention Program to the Health Practitioners' Monitoring Program. Also, clarifies that the purpose of the Program is to monitor impaired health professionals, rather than to intervene or treat them. ### Summary as introduced:
