UPDATE ON THE SANCTION REFERENCE STUDY:

It was noted for the record that the term "loss of license" referred to in the slide presentation had been revised to "removal from practice."

General discussion ensued concerning the desire to ascertain the impact on sanctioning in cases where there was intentional harm. Mr. Kauder explained that because of the inherently subjective nature of determining intent, it would be extraordinarily difficult to develop an objective, reliable measure.

NEW BUSINESS:

Dr. Carter presented a case category report by board that reflected cases that were non-clinical in nature. The report is incorporated into the minutes as Attachment 2. She informed the Committee that an indepth report would be presented at the April meeting and the presentation will include facility cases with the aim of assisting the health regulatory boards in addressing the impact of HB1441 (2003).
