## BUDGET PRESENTATION AND DISCUSSION:

Mr. Nebiker presented an overview of the agency manager budget requests and the recommended allocated

budget. The report is incorporated into the minutes as Attachment 1. He further detailed the items driving cost increases, including the increased caseload effects on Enforcement, the new regulation of Assisted Living Facility Administrators and Medication Aides and the consequential need for a new Board Executive Director position and staffing for the Board of Nursing, increased staffing costs for health care, upcoming retirement of several senior professional staff members, online renewal fees, and the as yet unknown impact of VITA costs.

The Committee requested the following materials and information be provided prior to their September 8, 2005 meeting to aide in the development of their recommendations to the full Board that date.

> (1) A draft letter to the Secretary of Health and Human Resources expressing the Board of Health Professions' shared concerns with the Board of Medicine over the requirement that the Board of Medicine provide part of its revenues (\$15 per licensee) to the Department of Health to offset student loans of practitioners in underserved areas.

> (2) A bulleted summary of cause and effects pertaining to legislative mandates which have increased the Department's workload. A personnel summary is to be included.

	(3) A comparison of budget requests versus actual expenditures by biennia for the past several biennia.
NEW BUSINESS:	Mr. Nebiker and Mr. Monson reported that they will be out of town during the September 8 <sup>th</sup> meeting. Ms. Jaspen and Mr. Giles will be attending.
