**PUBLIC COMMENT:**

**APPROVAL OF MINUTES:** 

On properly seconded motion by Dr. Hettler, the Board voted unanimously to adopt the minutes of the September 8, 2005 meeting.

DEPARTMENT DIRECTOR'S REPORT:

Mr. Nebiker had to attend the General Assembly Session and asked that the report be deferred to the next meeting.

EXECUTIVE DIRECTOR'S REPORT:

### Workplan

Dr. Carter presented the draft 2006 workplan and it is incorporated into the minutes as attachment 1.

#### Budget

Dr. Carter advised that the Board remained within its budget and could accommodate the workplan's activities.

REVIEW OF LEGISLATION AND REGULATORY PROPOSALS:

Ms. Yeatts updated the Board on the 2006 legislation that may impact the Department. The documents are incorporated into the minutes as Attachment 2.

#### **BOARD REPORTS:**

# **Board of Audiology and Speech Language Pathology** Dr. Ridenhour presented the Board's report and it is

incorporated into the minutes as Attachment 3.

#### **Board of Counseling**

Ms. Ward reported that plans were underway to celebrate the Board's 30<sup>th</sup> anniversary. Further, that Virginia was the first state to license counselors. The Board received training from Howard Casway on conducting informal conferences. Additionally, the Board was considering alternative disciplinary action for CE non-compliance.

#### **Long Term Care Administrators**

Ms. Smith reported that the Board was continuing its task force study for assisted living administrators and was going forward with regulations for licensing this profession.

#### **Board of Optometry**

Dr. Hettler presented the Board's report, and it is incorporated into the minutes as Attachment 4.

#### **Board of Pharmacy**

Ms. Aust presented the Board's report, and it is incorporated into the minutes as Attachment 5.

#### **Board of Physical Therapy**

Mr. Howell presented the Board's report, and it is incorporated into the minutes at Attachment 6.

#### **Board of Social Work**

Mr. Boehm reported that the Board had recently conducted a CE audit and the percentage of licensees with incomplete CE's was high. Additionally, the Board had proposed three (3) regulatory items relating to examination requirements, amendments to standards of practice and change in the returned check fee.

Regarding standards of practice issues, Mr. Boehm indicated that there is a consensus among the three behavioral science boards (Social Work, Counseling and Psychology) that the regulations pertaining to standards of practice for all these should be similar, with similar ethics and practice setting considerations.

#### **Board of Veterinary Medicine**

Dr. Wise presented the Board's report, and it is incorporated into the minutes as Attachment 7.

The following Boards forwarded written reports, and they are incorporated into the minutes as Attachment 8: Board of Funeral Directors and Embalmers, Board of Medicine, Board of Nursing, Board of Psychology.

#### **COMMITTEE REPORTS:**

#### **Practitioner Self-Referral**

Dr. Hettler reported that the Committee had met on December 16, 2005 to review draft recommendations for an advisory opinion from Vascular & Transplant Specialists. Dr. Hettler stated that it was the opinion of the Committee that Vascular did not fall within the Practitioner Self-Referral Act and presented the advisory opinion as follows:

- 1. If a physician refers a patient to Vascular and then provides the patient services at Vascular, there is no violation of the Act;
- 2. Vascular does not qualify as part of the referring

physician's practice group, from which he is referring patients;

3. Vascular qualifies as part of the referring physician's office practice if he provides or supervises the provision of health care services to patients on an ongoing basis at the Vascular facility.

On properly seconded motion by Dr. Hettler, the Board voted unanimously to accept the recommendations of the Committee.

#### **Regulatory Research Committee**

Dr. Hettler reported that the Committee had reviewed the issue of expunging minor disciplinary action that did not involve patient care against licensees. It was noted that if these same minor infractions occurred today, the licensee would be afforded a Confidential Consent Agreement. Additionally, a request was made to include the expungement of public information against a licensee that resulted from an informal conference but was closed with a no violation.

On properly seconded motion by Dr. Hettler, the Board voted unanimously to accept the recommendation of the Committee to develop a workplan regarding expungement of minor disciplinary action against licensees.

#### **Enforcement Committee**

Dr. Hettler reported that the Committee had received updates on the Sanction Reference Study and Agency Performance. He stated that it appeared that the agency's standards could be improved. The Committee also discussed and recommended a fall retreat be held to focus on the Board's mission, exchange of Board information, common goals and specific training in the subjects of impaired practitioners and sanctions.

On properly seconded motion by Dr. Hettler, the Board voted unanimously to accept the recommendations of the Committee.

## UPDATE ON ISSUES FORUM AND EDUCATIONAL BROCHURES:

#### **Educational Brochures**

Ms. Jolly presented the draft Informal Conference brochure. The brochure will be made available to the public, placed in all disciplinary case mail outs and on the agency webpage.

Ms. Jolly reported that she will be drafting individual board pamphlets for review and will start with the Board of Medicine's licensure application requirements by profession.

#### **Issues Forum**

Ms. Jolly reported that the date for the Issues Forum had not been set; however, the goals and agenda remained the same. Ms. Jolly presented the proposed Issues Forum agenda and it is incorporated into the minutes as Attachment 9.

It was suggested that the Issues Forum be held in conjunction with the Board's Fall 2006 retreat.

**NEW BUSINESS:** No new business was presented.

**ADJOURNMENT:** The meeting adjourned at 2:05 p.m.

#### HB 173 Medical and health services to minors; notification to parents.

Summary as introduced:

**Notification to parents of certain health services to minors.** Requires any state or local government agency employee who provides services to a minor relating to sexually transmitted diseases, the provision of emergency contraception, pregnancy, illegal drug use, or the contemplation of suicide to attempt notification, within two business days of delivery of such services, to a custodial parent, legal guardian, or other person standing in loco parentis of any service and any reason, condition, or diagnosis requiring such service.

## HB 187 Unmarried women; prohibition on provision of certain intervening medical technology.

Summary as introduced:

**Prohibition on the provision of certain intervening medical technology to unmarried women.** No individual licensed by a health regulatory board shall assist with or perform any intervening medical technology, whether in vivo or in vitro, for or on an unmarried woman that completely or partially replaces sexual intercourse as the means of conception, including, but not limited to, artificial insemination by donor, cryopreservation of gametes and embryos, invitro fertilization, embryo transfer, gamete intrafallopian tube transfer, and low tubal ovum transfer.

#### HB 237 Abortion services; requires physicians to reside and practice in State.

Summary as introduced:

**Certain requirements for physicians performing abortions.** Requires any physician performing abortions in the Commonwealth to reside and practice in Virginia and have practice privileges in a Virginia hospital. The Board of Medicine must monitor and verify that each such physician is a resident of and practices in Virginia and has practice privileges in a Virginia hospital.

# HB 299 Registered pharmacy tech.; authorized to accept oral prescriptions for certain radiopharmaceuticals.

Summary as introduced:

**Registered pharmacy technicians**. Authorizes registered pharmacy technicians to accept oral prescriptions for diagnostic, non-patient specific radiopharmaceuticals if working under the direct supervision of a qualified nuclear pharmacist.

## HB 300 Physician assistants; provides that they may sign various forms and certificates, etc.

Summary as introduced:

Physician assistants; forms and certificates. Provides that physician assistants may sign various forms and certificates, and provide medical information or treatment in certain situations, including situations involving the immunization of children, examination of persons suspected of having tuberculosis, required examinations of school bus drivers, prenatal tests, nursing home residents, release of certain privileged information, release of certain veterinary records, competency for driver's licenses, and assisted living facility residents. The bill also provides that whenever any law or regulation requires a signature, certification, stamp, verification, affidavit, or endorsement by a physician, it will be deemed to include a signature, certification, stamp, verification, affidavit, or endorsement by a physician assistant.

### HB 302 Nonresident pharmacies; inspections for those seeking registrations to conduct business.

Summary as introduced:

Inspections of nonresident pharmacies seeking registration to conduct business in the

Commonwealth. Deems an inspection report submitted by a nonresident pharmacy to be current if the inspection was conducted within the past five years. However, if the nonresident pharmacy has not been inspected by the regulatory or licensing agency of the jurisdiction in which it is licensed within the past five years, the Board may accept an inspection report or other documentation from another entity that is satisfactory to the Board or the Board may cause an inspection to be conducted by its duly authorized agent and may charge an inspection fee in an amount sufficient to cover the costs of the inspection. Technical amendments clarify that the nonresident pharmacy must disclose that it maintains a current unrestricted license in its home jurisdiction.

## HB 332 Nursing education programs; to report to Board of Nursing annually their enrollment, etc.

**Health professions; nursing education programs.** Requires all nursing education programs to report to the Board of Nursing annually their enrollment, graduation rate, attrition rate, and number of qualified applicants that are denied admission, according to the Board's guidelines.

### HB 351 Health regulatory boards; prohibition of certain transfers of moneys collected on behalf thereof.

**Prohibition of certain transfers of moneys collected on behalf of health regulatory boards.** Requires that all nongeneral funds generated by fees collected on behalf of the health regulatory boards and accounted for and deposited into a special fund by the Director of the Department of Health Professions must be held exclusively to cover the expenses of the health regulatory boards, the Health Practitioners' Intervention Program, and the Department and Board of Health Professions and cannot be transferred to any agency other than the Department of Health Professions.

#### HB 412 Gamete donors; anonymous donations thereof prohibited in medical procedures.

Summary as introduced:

**Identification of gamete donors.** Prohibits the use of unrelated anonymous donor oocyte or sperm in the performance of intervening medical technology that completely or partially replaces sexual intercourse as a means of conception and requires, notwithstanding any traditional practice, agreement, regulation, or law to the contrary, the identity of any unrelated oocyte or sperm donor to be noted in the health record of any woman patient whenever any healthcare practitioner licensed by a health regulatory board uses any unrelated donor gametes in the performance of or while assisting in the performance of such intervening medical technology, such as artificial insemination by donor, cryopreservation of gametes and embryos, in vitro fertilization, embryo transfer, gamete intrafallopian tube transfer, and low tubal ovum transfer.

#### HB 443 Health care provider; definition includes marriage and family therapists.

Summary as introduced:

Marriage and family therapists; professional counselors. Adds marriage and family therapists to the definition of "health care provider" under medical malpractice provisions, specifies that such therapists be licensed to receive immunity as a member of a substance abuse intervention team for health professionals and to give treatment under substance abuse insurance coverage provisions, and adds licensed marriage and family therapists and licensed professional counselors to the definition of "medical professional" for insurance information and privacy protection provisions.

# HB 505 Methamphetamine precursor drugs; sale of ephedrine and pseudoephedrine with restrictions, penalty.

Summary as introduced:

Sale of methamphetamine precursor drugs ephedrine and pseudoephedrine; penalty. Provides that no person shall offer methamphetamine precursor drugs (ephedrine and pseudoephedrine) for retail sale except from behind the counter or with other comparable restrictions. No more than three packages may be sold. No more than nine grams may be sold. The seller is also required to record the purchaser's name and the date of purchase. The purchaser must sign the purchase log. The log may not be revealed except to law enforcement. A violation of this provision is a Class 1 misdemeanor.

#### HB 571 Preneed funeral contracts; clarifies deposits in trust accounts thereof.

*Summary as introduced:* 

**Board of Funeral Directors and Embalmers; preneed funeral contracts.** Clarifies that deposits in a preneed funeral trust account may be commingled for the purposes of the management of the trust account or investment of funds in the trust account.

# For BHP meeting of January 17, 2006 **BOARD OF AUDIOLOGY AND SPEECH-LANGUAGE PATHOLOGY**

- The Board of Audiology and Speech-Language Pathology submitted its 2006 legislative proposal to the Department. The legislation has been introduced and by Delegate Hamilton. The proposal establishes a provisional license in audiology. Due the changing degree requirements in the field of audiology, there is a need for a clinical internship after completing the Master's degree requirements.
- The Board of Audiology and Speech-Language Pathology completed a renewal cycle ending December 31, 2005. For the 2006 renewal period, evidence of continuing competency will be required.

### Board of Pharmacy Report to the Board of Health Professions January 17, 2006

#### **Legislation:**

The Board of Pharmacy this year has sought the introduction of two bills. The first, HB 302 is related to registration of non-resident pharmacies. The Board has had difficulty in registering pharmacies in North Carolina that want to do business in Virginia as well as several other states because the resident state boards of pharmacy do not conduct opening and/or routine inspections in a timely manner. The bill establishes that the inspection must be done within the past 5 years in order to be "current" and will allow the Board to accept an inspection done by another entity acceptable to the Board other than the resident state board. It will also allow the Virginia Board to have its own agent conduct the inspection and make a reasonable charge to cover the cost of the inspection. HB 937 is the annual rescheduling bill where state drug schedules as well as other sections of the Drug Control Act are conformed to changes made in federal regulation by the U.S. Drug Enforcement Administration (DEA). This year's changes relate to changes to allow for electronic ordering of Schedule II drugs by practitioners and pharmacies, the addition of two new drugs to Schedule IV and V and some changes in the definition and scheduling of anabolic steroids.

There are a number of other bills that have been introduced related to the practice of pharmacy or the Drug Control Act. Several bills have been introduced to modify previous legislation related to the establishment of a pedigree system to ensure the integrity of prescription drugs through the distribution system. The bills all seek to remove the pedigree requirement for the "normal" distribution chain, but differ in how they define normal. The Board has essentially put its rulemaking process for a pedigree system on hold until the outcome of this legislative session.

#### **Regulations:**

New regulations just went into effect January 11, 2006 which change the default time that a Schedule VI prescription may be refilled when the prescriber indicates prn refills, from two years to one year. A prescriber may extend this time for a period not to exceed two years by so indicating on the prescription.

New regulations, as a result of a comprehensive review, relating to physicians dispensing will go into effect on February 22, 2006. Numerous changes were made to these regulations, some to accommodate electronic prescribing, and some related to the recent change that required minimum competency and registration of pharmacy technicians.

The Board has also published a notice of periodic review of its main set of regulations. It will begin a comprehensive review in approximately March 2006.

### **New Board member:**

Michele Easton has resigned from the Board of Pharmacy effective December 31, 2005 as a result of a relocation to West Virginia. She has been replaced by Michael Stredler of Virginia Beach.

# For BHP meeting of January 17, 2006 **BOARD OF PHYSICAL THERAPY**

- There are currently two house bills in the General Assembly which amend the statute governing physical therapy: direct access to physical therapist by the public excluding invasive procedures and an advertising restriction for other professions that may provide physical therapy services.
- The Board of Physical Therapy adopted amended regulations allowing the acceptance of other foreign credentialing firms for licensure. Currently the Board of Physical Therapy only accepts foreign credentialing evaluations by the Foreign Commission on Credentialing of Physical Therapy.
- The Board of Physical Therapy voted to reduce fees and change its renewal dates from the licensee's birthday month to December 31<sup>st</sup> of each even year. New licenses with the December 31, 2006 expiration date were issue to all licensees.

### Board of Veterinary Medicine Report to the Board of Health Professions January 16, 2006

- Since the last BHP meeting in September, the Board of Veterinary Medicine has continued to note an increase in the number of complaints and facility inspection problems related to drug diversion and potential drug diversion (i.e., poor drug recordkeeping). At the November 2005 full Board meeting, the Board held a Questions and Answers Session on Drug Issues with Enforcement and HPIP staff to better help coordinate efforts in dealing with these cases.
- Because education and communication is a key to help resolve the problem, the Board will be holding a Panel Discussion at the annual conference of the Virginia Veterinary Medical Association in early February to help educate licensees about this important concern and others such as the Board's periodic review of regulations which is scheduled to begin this year.
- Among the "other issues" on the horizon discussed previously with BHP is the practice of human health care professions (i.e., massage therapy, physical therapy, chiropractic) on animals. Veterinary medicine's scope of practice is extremely broad, and basically entails all diagnosis, treatment, remediation, relief, etc. pertaining to animals. But, more and more, other groups, including non-human health care practitioners such as equine dentists, are becoming involved in animal health care.
- Finally, as discussed at the last BHP meeting, the Board of Veterinary Medicine's staffing is anticipated to change, beginning July 1, if the agency's budget is approved. A new Executive Director position is being created to oversee the Board of Long-Term Care Administrators and the Boards of Audiology & Speech-Language Pathology and Physical Therapy (currently managed by Sandy Reen (who also has Dentistry) and Elizabeth Young, who also has the Board of Funeral Directors & Embalmers). Ms. Young will then receive the Board of Veterinary Medicine from Dr. Carter, who now manages the Boards of Optometry, Health Professions, as well as Veterinary Medicine.

# For BHP meeting of January 17, 2006 **FUNERAL DIRECTORS AND EMBALMERS**

- There are currently five funeral service bills introduced in the 2006 Virginia General Assembly: revising the occupational title of "resident trainee" to "funeral service intern", requiring only violators of the law to obtain continuing education units, creation of a preneed recovery fund, allowing the commingling of trust funds, and raising the Medicaid exception from \$2500 to \$5000.
- The Board of Funeral Directors and Embalmers continues its periodic review of its three regulations: general and preneed funeral planning.
- The Board of Funeral Directors and Embalmers continues its study of the preneed funding laws of other states in an effort to amend it current preneed laws.

#### BOARD OF MEDICINE REPORT

to the

#### **BOARD OF HEALTH PROFESSIONS**

January 17, 2006

- 1. The Board of Medicine's Standards of Professional conduct for all its licensees became effective October 19, 2005. They have been included in the Board's newsletter which is now, or will shortly be, in the mail to 46,000+ licensees.
- 2. The Board licensed its first Certified Professional Midwife in December. Befittingly, the first licensee was Leslie Payne, chair of the Advisory Board on Midwifery.
- 3. At its November 2005 meeting, the Board voted to accept the recommendations of the Ad Hoc Committee on Laser (Light-based) Hair Removal. The committee will reconvene to draft a guidance document on this matter.
- 4. The Board's regulations on Mixing, Diluting and Reconstituting of Drugs for administration in physicians' practices became effective in December 2005. A special newsletter is being drafted to inform the approximately 33,000 licensees that will be affected by these regs.
- 5. The Board of Medicine has a new citizen member, replacing Carol Comstock of the 7<sup>th</sup> Congressional District. The new member is Ann Burks of the 4<sup>th</sup> Congressional District.

#### Board of Nursing Report to Board of Health Professions

#### January 17, 2006

<u>Executive Order 97</u> - nine temporary registered nurse licenses, four nurse practitioner licenses, one authorization to prescribe license and one clinical nurse specialist license have been issued. In addition, an increase in the number of licenses issued by the regular endorsement process has been noted with the initial state of licensure being Louisiana and Mississippi.

<u>Regulatory Activity</u> – At its November meeting, the Board of Nursing adopted the following regulations:

- Final regulations to increase nurse aide fees from \$45 to \$50 per biennium. These fees will be effective January 26, 2006.
- Nurse Licensure Compact two additional states have passed legislation to join the NLC. New Hampshire entered the compact effective January 1, 2006 and South Carolina will enter the compact February 1, 2006. They join the following eighteen states; Arizona, Arkansas, Delaware, Idaho, Iowa, Maine, Maryland, Mississippi, Nebraska, New Mexico, North Carolina, North Dakota, South Dakota, Tennessee, Texas, Utah, Virginia and Wisconsin. Five other states are planning to introduce legislation this year for a registered nurse or licensed practical nurse to hold a license in her primary compact state of residence and practice under a multi state privilege in the other compact states.
- Regulations governing the practice of nursing (Chapter 20) and regulations governing the practice of nurse aides (Chapter 25).
- Regulations governing the practice of nurse practitioners (18 VAC 90-30-80) and to promulgate the amendments under a fast track action. These regulations address provisional licensure.
- Regulation of medication aides The Board approved the interim progress report to the Committees of the General Assembly.

<u>Sanction Reference Study</u> – The Board of Nursing continues to participate in sanction reference study development phase. Neal Kauder and staff have met with the Board of Nursing and the Discipline Committee reviewing factor analysis and the development of worksheets.

<u>Guidance Document</u> – The Board of Nursing at its September meeting adopted a joint guidance document with the Department of Health "The Impact of Criminal Convictions on Nursing Licensure and Employment in Virginia". Positive feedback has been received from employers and nursing education programs who frequently have concerns and questions about these issues.

### Board of Psychology January 17, 2006

At the January 10, 2006 meeting, the Board reported that renewal fees will *probably* Be cut at the next annual renewal, that is, June 30, 2006.

The one time 50% fee reduction for psychologists, the fee will change from \$70 to \$35.

At the 2007 renewal, probably the renewal fee will return to \$70.
