ISSUES FORUM AND BOARD MEMBER

RETREAT:

Dr. Carter and Ms. Jolly presented the tentative programs/topics of the Citizen Advocacy Center (CAC) annual meeting and the BHP Issues Forum. CAC provides training, research, conferences and networking for public members and consumer representatives on boards and other health care organizations. The CAC programs are scheduled to begin October 17, 2006 in Williamsburg. The BHP Issues Forum will take place the afternoon of the 20th. It was suggested that an overview of the responsibility of the Board of Health Professions be presented as well as a brief summary of the Sanction Reference

Study at the CAC meeting.

Due to budget issues, it was noted that each board

could send its board chair and a designated member to attend the Issues Forum. It was suggested that common topics across boards be discussed in breakout sessions over lunch. The suggested topics included: budget, enforcement, informal fact finding, CCA's, CE, privacy of disciplinary action, shortage of applicants and prescription monitoring. The suggested titling for the program, "Transparency Accountability Made Local."

A deadline of mid June was set to receive suggested agenda and/or topics from each board for the Issues Forum. The CAC's agenda is anticipated to be final by July and will be distributed accordingly.

Ms. Jolly informed the Committee that a brochure is being developed for the Board of Medicine's licensure application process and compliance.

Ms. Jolly also shared with the Committee a brochure prepared for DHP that describes an upcoming free continuing educational session designed for physicians and pharmacists on addiction and the risk of controlled substance diversion. The session is entitled, "Controlled Substances: Use, Misuse, and Abuse: The Role of the Health Professional" and will be held on April 29 at the Edward Via Virginia College of Osteopathic Medicine in Blacksburg.
