#2. Comments on the Proposed Regulations on Standards of Conduct

Ms. Carr moved to recommend adoption of the proposed regulations to the full Board with the suggested amendment to 18VAC85-40-86 E. (1)(a). The motion was seconded and carried unanimously.

#3. Regulations Governing the Practice of Licensed Acupuncture

Ms. Yeatts presented a chart showing the status of regulations. No action was necessary.

#4. House Bill #455

The Board discussed the definition of "medical nutrition therapy" in HB #455 and its impact on the scope of practice for Licensed Acupuncturists. Ms. Yeatts related that this topic will be studied to determine the need to license dietitians.
