CLOSED SESSION:

On properly seconded motion by Ms. Blackwell, the Board recessed Open Session and convened in Closed Session pursuant to §2.2-3711(A)(28) of the Code of Virginia for the purpose of deliberation to reach a decision in the matter of Ayman A. **Salem, DVM.** Additionally, it was moved that Eric Gregory, Assistant Attorney General and Elizabeth Carter, Executive Director, Board of Veterinary Medicine, attend the closed meeting because their presence in the closed meeting was deemed necessary and would aid the Committee in its deliberations. Having certified that the matters discussed in the preceding closed session met the requirements of §2.2-3712 of the Code, the Committee reconvened in open session and announced its decision.

DECISION:

On properly seconded motion by Dr. Froeling, the Board voted unanimously to dismiss the charges on case #'s 113145 and 109210 and to accept certain Findings of Fact and Conclusions of Law on case # 110023 and impose the following sanctions: a reprimand, a \$1000 monetary penalty, 6 hours of Board approved continuing education in small animal soft tissue surgery, 3 hours of continuing education in practice management and his facility will be subject to one unannounced inspection with 10 random records pulled for Board review.
