Chairman's Business

Chairman Mark Peterson officially called the meeting to order at 1:06 p.m.

First order of business was to approve the January 18, 2012 minutes. Motion to approve minutes was made by Vice-Chairman John Isom and seconded by Chairman Mark Peterson. The minutes were approved unanimously.

The next order of business was discussion on VOF Conservation Easement Amendment for Luck Stone Tunnel. Currently the approved agreement with the VOF easement allows for a conveyer belt (over bridge over Goose Creek) system not a tunnel. Erika Richardson with VOF provide background inform on the easement and requested sign off from the GCSRC to amend the conservation easement to allow for a tunnel.

Vice-Chairman John Isom made the following motion, "When decision is made on the amendment by VOF for the tunnel. The chairman on behalf of the Gosse Creek Scenic Rive Advisory Committee is authorized to sign off". Second by Phil Daley, motion passed unanimously.

Next order of business was an update on the Chesapeake Bay TMDL – Virginia Phase II WIP. Alan Brewer with the Loudoun County Department of Construction and Waste Management and Randy Williford with Loudoun County General Services provided an update. Staff has asked the Board of Supervisors to direct staff to implement the amended Phase II Watershed Implementation Plan (WIP) Community Outreach Plan. The Community Outreach Work Plan engages stakeholders and provides community outreach in an effort to find the most reasonable and cost effective strategies for meeting the requirements of the WIP.

The next order of business was an information item presented by Loudoun Water (Marc Schwartz). Loudoun Water, to improve its water flow/capacity, is proposing a waterline crossing (12 " main) of the Gosse Creek to existing waterlines on the north (Red Cedar) and south (Evergreen Village) of Gosse Creek.
