TIME AND PLACE

The Public Meeting to consider the Master Plan for Pocahontas State Park took place at 6:00 p.m. on Thursday, October 6, 2016, at the Heritage Center at Pocahontas State Park in Chesterfield, Virginia.

PUBLIC PRESENT

Thirty-six members of the public attended the meeting.

MEETING SUMMARY

Staff began the meeting with a brief history of Virginia State Parks, presented an overview of the master planning process, provided an orientation to Pocahontas State Park, reviewed the proposed update to the park's master plan and requested comments from attendees. Proposed developments for the park include improvements and additions to park trails for hiking, biking and equestrian use, cabins, upgrades to pool complex, a park office/welcome center and the renovation to or replacement of many park structures. A majority of the public comments expressed the desire for more single-use mountain bike, hiking and equestrian trails, and supporting the conversion of multi-use trails to single use. Support for a connection between Pocahontas State Park and the James River park system was expressed, as well as the completion of the planned Richmond Ride Center. Many members of the public expressed the desire for user groups to work together, for strength in numbers, so everyone can enjoy Pocahontas State Park. Concerns were expressed for water quality in the creeks and lakes, and for the protection of habitat and natural communities in the park. Concern was expressed on how park projects are prioritized and funded considering the best interest of the park and its users. Comments were also made to have facilities that support programs that educate the next generation to the value of nature and outdoor recreational pursuits. Next, the draft master plan will be presented to the Board of Conservation and Recreation for their review.

Pocahontas State Park Master Plan Draft Phased Development Plan October 3, 2016 DRAFT

Proposed developments for the Park are presented in priority order. Completion of all of the projects in this list will represent total build-out (completion of the master plan), and covers a 20-year timeframe. The phasing costs are based on 2016 estimates.

Phase I

Construct ride center with parking (100 spaces), comfort station, shelter, outdoor showers staging area, training center, contact station mountain bike trails

Construct 20 cabins with support facilities and access road

Renovate cabins, lodges and support buildings at Swift Creek and Ecology Camps

Replace bathrooms (4) at Swift Creek and Ecology Camps

Replace comfort stations in picnic area

Pool facility upgrades

Park office/welcome center with park store

Upgrade boat ramp area with canoe launch, parking, fishing nodes and road improvements

Upgrade bathhouses (2) at northern campground loop

Playground at Amphitheater

Upgrade picnic shelters 4-7, construct additional parking, better access and a playground

Construct logistics center and sign shop

Replace bathhouses (2) at southern campground loop

Single and multi-use trail improvements and additions for hiking, biking and equestrian

Phase II

Construct Discovery Center

Improve park entrance (add turning lanes) add traffic lane from entrance to contact station Add pedestrian cross walk on Beach Road (2 potential sites identified)

Add a bridge crossing of Swift Creek

Stabilize water towers and develop interpretive signage

Upgrade park roads (3.0 miles)

Increase dump station capacity (add an additional station)

Repurpose existing logistics center for park maintenance

Single and multi-use trail improvements and additions for hiking, biking and equestrian

Phase III

Renovate district IV office

Comfort station at Beaver Lake

Renovate amphitheater

Bright Hope Horse Complex improvements

Staff residence

Single and multi-use trail improvements and additions for hiking, biking and equestrian
