<u>Minutes</u> - October 18, 2018 minutes – Motion by John Thompson to approve, seconded by John Moeser, approved unanimously.

Current Issues:

• Riverfront Development Plan:

- Downriver Updates: Terminal Building disposition. Leighton Powell relayed that Stone Brewery had pulled the two papers that were before City Council concerning the demolition of the Intermediate Terminal Building. It is uncertain what Stone will consider now. She added that this was an opportunity for the Falls Committee to be part of the discussion and indicated that perhaps Stone might not be as enthused about the project as before. She also added that this whole process shed light on just how bad the EDA's deal was for the riverfront and the Richmond pubic. It is important for us to thank the Mayor for pulling the papers off the agenda and to let City Council members know what a raw deal was made between the City and Stone. The beer garden site could be open to all people or this could be a site for a James River history museum or effort. Leighton will draft a letter from the Falls Committee to the Mayor and Council members thanking the Mayor and illuminating the EDA's deal and importance of keeping with the Riverfront and Downriver Plans. John Moeser thanked Leighton for her leadership in this matter. John Heerwald went on to add that the reversion of the property to the City (should Stone opt out of the property) was in the original contract but EDA took it out.
- BridgePark RVA: Ted Elmore (interrupted the agenda for presentation) The BridgePark RVA project as now envisioned as a 2-mile Greenway that would include a streetscape from the north 9th and Leigh (bringing 4 underserved neighborhoods together including across the MLK Bridge) continuing down and across the Manchester Bridge to Commerce Street—Green Spine of the City. He alluded to the project somewhat mimicking Olmstead's 'Emerald Necklace' of Boston's City Parks connecting the Commons to Franklin Park with the first jewel being Coliseum Park. Support is needed to have this project incorporated into the Riverfront Development Plan and developed into a public/private partnership in stages. The Committee decided that if it can get the attendance commitments, the December 20, 2018 Falls meeting will be held at BridgePark headquarters at Riverfront Plaza 9th & Byrd Streets. This way Ted can make a presentation using the giant model. Need Committee member commitments.

• Riverfront Development Plan:

O Potterfield Bridge: From Mark Olinger: Concerning lights: "Parks issue now. PDR will come back through and plant some trees in the spring that have died, but we're not involved in lighting now." Questions were raised: Is the Potterfield in the Conservation Easement? And Michael Burton about new lights? Since maintenance seems to be such an expense – need to know exact projected figures as well

as perhaps look into sharing those expenses regionally.

- Missing Link Budget Appropriation: Mark Olinger: "Survey work for Missing Link project is nearly complete. Hargreaves Associates will turn their attention to the project in the near future. Survey work is about complete, as per notes; however, we're still working to get the final pieces done that are on Norfolk Southern land which is hampering completion. Hargreaves set to begin as soon as survey done...schedule of meetings, etc., to come as soon as we get the survey work finished." Justin Doyle also wrote: "Accessing the Norfolk Southern property requires a Right-of-Entry form. Hargreaves Associates will turn their attention to the project in the near future. All contract pieces are in place for the project to move forward."
- **Representation of Planning Department at Meeting:** Mark Olinger indicated that should be him. We agreed to try to find a time for his presentation, so he didn't have to sit through the entire Committee meeting.

Scenic River Designation Extension:

- John Moeser expressed frustration at his attempts to schedule a time to make a presentation to the RPC concerning the benefits of the Scenic River designation and the work that the Falls Committee does for the Cit of Richmond's segment.
- Lynn Crump responded by email concerning evaluation western/eastern segments of the James for Scenic River designation: "I was actually on the James in Lynchburg yesterday. They are looking at putting in a white water park there. Anyway, in answer to your question. You could ask for both sections at the same time and we could, if the logistics worked out, do it in one day. Just two things for consideration: the ask needs to come from all impacted localities and I would hope to get the ask so we could do it in the late spring 2019 for submission to the General Assembly in 2020." Greg, Tricia and others need to meet with Lynn to ask questions about the local procedure.
- VA Scenic Rivers Program 50th Anniversary Effort & Potential Legislation for VDOT's Waterways & State
 Scenic River Signage Program: From Lynn Crump via e-mail:
 - We have Boat stickers w/our logo to hand out.
 - The Board of Conservation and Recreation met a voted to support recommendations from the Scenic Resources subcommittee [below].
 - O VA Tourism has offered us the opportunity to get 'Virginia is for RIVER Lovers branded'- if we want.
 - Carl Espy is working with Del. Edmonds on the signage issue. If you have ideas please reach out to them.
 - We hope to set up a meeting between now and the end of this year. If you have big blocks of time when you are not available, please send them to me so I can cull them down and set some options up.
 - Tricia Asked why there is no Scenic River sign on the I-95 James River Bridge?
- Enrichmond Vauxhall Island Cede to City of Richmond Update: From Mark Olinger: "Transfer to City of Richmond update Ordinance for transfer of Vauxhall to City set for introduction on 11/12 (I'll let you know Tues. night if that is NOT the case, but should be). Planning Commission and Council in December. Hope is to close shortly thereafter if all closing matters settled."
 What is conservation easement status?
- Falls of the James Signage and Media Update: No change. We could add information, but need text.
- James River Park MasterPlan: Meetings are underway to determine the process of soliciting information for the
 plan. Next Steering Committee meeting is Dec 4, 2018. In a related revelation it was learned that the JRP
 Conservation Easement document has finally been completed and that only a portion of the JRP is actually under
 conservation easement.
- CRLC Updates Parker Agelasto was not present

 DPU updates – Grace LeRose was not present, but Greg Velzy added that RVAH2O is receiving an award November 29th

New Business:

- World Rivers Center There was news of a proposed Whitewater Outdoor Center for Richmond, perhaps on Mayo's Island. The idea would be a Center similar to Nantahala with perhaps a play feature in the river. There is also a push to locate the Whitewater Hall of Fame in Richmond. Need more information.
