MEETING SUMMARY

The meeting introduced the history of Virginia State Parks, provided an overview of the master planning process, provided an orientation to Leesylvania State Park, reviewed the proposed update to the park's master plan and allowed for public comment. Proposed developments for the park include renovations to park comfort stations, 5 picnic pods, amphitheater, re-design of road and parking at contact station, addition of a turning lane on Neabsco Road, expanded office and maintenance area, and a disc golf trail. Public comments included a need for better access to the park on busy weekends, an off-road multiuse trail along the park road, discovery play area, pier/parking at Bushey Point, and landscaping to restore park's natural. The citizens in attendance expressed general support for the plan. The draft master plan will next be presented to the Board of Conservation and Recreation for recommended approval.

Leesylvania State Park Phased Development Plan

Proposed developments for the Park are presented in priority order. Completion of all of the projects in this list will represent total build-out (completion of the master plan), and covers a 30-year timeframe. The phasing costs are based on 2019 cost estimates.

The estimated total cost to bring Leesylvania State Park to its desired future condition is \$

Phase I:

Reconfigure contact station/park entrance (use technology to control traffic/collect revenue)

Create/extend turning lane on Neabsco Road into park

Renovate comfort stations (2) in picnic area

Renovate comfort station at concession building

Construct outdoor shower stations (2) at each picnic area comfort station.

Expand maintenance area with storage/office building and 10 parking spaces

Construct elevated observation platform at Freestone Point

Replace 2 Large Playgrounds each with 2-5 year old and 5-12 year old component structures

Upgrade pier and dock at Powell's Creek paddle launch

Relocate canoe rental facility, add storage and electric/water

Reconfigure picnic area with expanded picnic pads, 5 covered shelters; gravel road/parking

Dredge marina (now and every 15 years, see Phase III also)

Improve landscaping to restore the natural appearance of the park

Total Cost of Phase I:

Construct comfort station with a single shower at group camp

Expand park office

Create a discovery play area near visitor center

Expand (20 spaces) boat storage area, add covered storage

Improve landscaping to restore the natural appearance of the park.

Total Cost of Phase II:

Phase III:

Construct small amphitheater behind visitor center (100 seats)

Add fish weigh-in station with small office, electricity, holding tank and chute

Develop disc golf course

Dredge marina (every 15 years – see Phase I)

Improve landscaping to restore the natural appearance of the park.

Total Cost of Phase III:

Project costs will be determined once phase development plan is finalized.
