## **Current Issues:**

- Mayor Stoney"s 2020 Budget and Appropriations for James River Park and Projects: Justin Doyle stated that the budget/economic subcommittee hearing would be held Monday, April 22, 2019 at 6:00pm, City Hall. This is an opportunity to speak on behalf of funding for James River related projects. Justin added that he felt good about the state of the approximately \$900,000 proposed for the River and was continuing to advocate for Missing Link funding. He added that there had been support from Council members, Parker Agelasto and Kristen Larson. Bryce Wilk added that at the moment there was no funding for repair/replacement of the Texas Beach tower (which will be evaluated for safety soon), but there was \$40,000 for evaluating 22nd Street and 42nd Street towers.
- Riverfront Development Plan Planning Department Updates: Mark Olinger, Director of Planning and Development Review, City of Richmond could not be present but relayed via Greg Velzy that he would report back on the Missing Link survey in May and provide again a timeline for parking at Diversity Park. Tricia gave a shout out to Southern States for allowing parking on their property during shad season.
- Riverfront Development Plan -Downriver Updates: Leighton Powell had none. She will try to find out what's happening by the May meeting.
- Councilwoman Kimberly B. Gray:
  - Encouraged us to read the article in Richmond Magazine May issue concerning the very first Richmond City High School Rowing Team – a partnership between Richmond City Rowing and RPS and Franklin Military Academy.
  - She also indicated that everyone (City Council) loves the JRPS and riverfront and doubted that the proposed river funding would be subjected to the 1.5% across-the-board cut in funding appropriation.
- VA Scenic Rivers Program 50th Anniversary: The next 50th Anniversary Meeting will be held at Covenant Woods (Mechanicsville, VA) on May 7, 2019 from 10-12. Tricia and Greg can't attend. John Heerwald and Justin Doyle indicated they could attend.
- Virginia Scenic James River Designation Extension:
  - John Moeser was disappointed that Henrico had not responded to the request for a Scenic River study and said he would write to John Vithoulkas to see if he couldn't spark some action.
  - o Greg said that he had sent a letter answering all of Janit Llewellyn's (Chesterfield County) concerns.

• **James River Park MasterPlan:** Bruce Wilk reported that over 2000 surveys have been received and now they are crunching numbers. VHB will present a preliminary rough draft at a public meeting in June.

- **JRA:** Justin Doyle explained that they were undergoing testing and sampling of sediment and water quality in preparation for the State of the James Report. 2018-2019 had been a particularly wet year.
- CRLC Updates: Parker Agelasto/Jane Myers not present, but Greg/Bryce talked with Jane Myers. She was
  suggesting that volunteers adopt a section of the JRPS to monitor Conservation Easement over a year's time. She is on
  track to have enough volunteers to complete this project.
- **DPU updates**: Grace LeRose was not present.



WHEREAS, the Virginia Scenic Rivers Program was established in 1970 and will celebrate its 50th anniversary in 2020; and WHEREAS, the Virginia Scenic Rivers Program designates and helps protect rivers and streams that possess outstanding scenic, recreational, historic, and natural characteristics that are of statewide significance; and

WHEREAS, scenic river designations result from initiatives launched by partnerships between local organizations, local governments, state agencies, and the General Assembly of Virginia; and

WHEREAS, since the advent of the program, 33 river segments totaling more than 850 river miles have been designated as state scenic rivers; and

WHEREAS, the Virginia Department of Conservation and Recreation administers the Virginia Scenic Rivers Program, is assisted and advised by the Board of Conservation and Recreation, and receives guidance from locally appointed advisory committees; and

WHEREAS, rivers possessing outstanding scenic qualities continue to be evaluated and added to the Virginia Scenic Rivers system; now, therefore, be it

RESOLVED, by the House of Delegates, the Senate concurring, That the General Assembly hereby commend the Virginia Scenic Rivers Program in advance of its 50th anniversary so that the Board of Conservation and Recreation, the Virginia Department of Conservation and Recreation, advisory committees, interested citizens, and local governments may plan for appropriate celebrations in 2020; and, be it
