Ms. Booth inquired about the forest mitigation projects and whether the replacement was one for one. She noted that when trees are planted they also require monitoring. The goal of the program is to protect other large tracts of land to ensure that they are not also divided.

Ms. White responded that the funding was brought to the state for forest fragmentation. The damaged resources are lost and could not be replaced one for one.

Mr. Powell asked how VOF was defining community support.

Ms. White advised that community support was gaged from letters of support and significant interest in the property. The same scoring sheets are used regardless of the category. If a project is not competitive on an ecological level but has a large amount of community support that will be considered.

UPDATE ON COMPLETED VLCF GRANT AWARDS – Suzan Bulbulkaya, Land Conservation Manager, DCR

Ms. Bulbulkaya noted that the following eleven (11) VLCF grants successfully closed since the September 25, 2018 Board meeting.

BOARD ACTION

Mr. Woodley moved that the Virginia Land Conservation Foundation Board of Trustees approve the proposed FY20 VLCF Grant Schedule as presented by staff. Ms. Hubbard seconded and the motion carried.

<u>APPROVAL OF FY20 GRANT MANUAL</u> – Larry Mikkelson, Land Conservation Specialist, DCR, and Suzan Bulbulkaya

Mr. Mikkelson reviewed the proposed DRAFT FY20 Grant Manual. He noted that the draft had been sent to members earlier in the month.

Mr. Mikkelson noted the following changes to the manual:

- The Governor's Conserve Virginia initiative was included.
- Areas were revised to strengthen how the program addresses water quality.
- The manual was rearranged into four major sections. These were not substantive changes, but a reorganization of material.
 - Grant program overview
 - Applying for the grant program
 - Application review and grant award section
 - Application

Mr. Mikkelson noted that the revisions were intended to aid applicants in understanding the program and the application process.

Specific changes included:

- For Open Space and Parks, two different models are used to come up with twenty (20) points. These models include recreation resources in an area as well as scenic or protected spaces.
- For the purposes of water quality, a minimum 35 ft. buffer would be required on all perennial streams and shorelines. Additional points may be awarded for wider buffers or forest buffers.
- Additional points may be awarded for the presence of wildlife. A larger number would be awarded if the wildlife included rare or endangered species.

Mr. Pollard proposed the following grammatical edit on Page 7 of the manual.

2. Historic Area Preservation Category – contact and Easement Program staff member at the Virginia Department of Historic Resources (DHR). (804) 367-2323, with questions. Additional information may be found on DHR's website, www.dhr.virginia.gov. We encourage applications for projects that conserve historic lands associated with underserved populations. Those projects that also provide public educational opportunities and share untold stories to advance historic equity are particularly encouraged.

BOARD ACTION

Mr. Pollard moved that the Virginia Land Conservation Foundation approve the amendment to the draft manual as proposed, allowing staff edits for clarity. Mr. Ford seconded and the motion carried.

Mr. Pollard proposed that the second paragraph on page 12 of the draft be amended to read. "Visual access means the applicant can demonstrate the scenic value of the property and that the project will protect the integrity of *the public's scenic view.*"

BOARD ACTION

Mr. Pollard moved that the Virginia Land Conservation Foundation approve the amendment to the draft manual as proposed. Mr. Woodley seconded and the motion carried.

BOARD ACTION

Mr. Woodley moved that the Virginia Land Conservation Foundation approve the DRAFT FY20 Grant Manual as presented by staff and as amended by Board action. Ms. Lawson seconded and the motion carried.

BOARD MEMBER COMMENT AND DISCUSSION

Mr. Ford inquired about the process of notifying the Board if a particular grant is amended or withdrawn.

Director Cristman advised that, in the grant approval process, DCR has some discretion regarding negotiations. DCR cannot change the requirements of the approved grant manual, but must work to ensure that the projects are proceeding according to guidelines and in accordance with the intent of the approved grant. He advised that if there were a major issue, the Board would be informed prior to staff action.

PUBLIC COMMENT

There was no public comment.

Director Cristman advised that the next meeting of the Board would be in October, in accordance with the approved grant round schedule. Staff will poll the Board for dates in mid-October.

There was no further business and the meeting adjourned at 12:53 p.m.
