Mr. Page reviewed the current condition and future vision for high speed rail in the Commonwealth, and current and new passenger rail service in the Commonwealth including the ARRA application process.

## Winter Storm Event/Lessons Learned – Rail Perspective

Jay McArthur of Amtrak, Dale Zehner of Virginia Railway Express, Steve Powell of Buckingham Branch Railroad, Quintin Kendall of CSX and Bill Shafer of Norfolk Southern reviewed their railroad preparations before, activities during and recovery after the recent winter weather events.

### Richmond/Hampton Roads Passenger Rail Project Update
