#### PUBLIC PARTICIPATION

# SPECIAL INSTRUCTIONS FOR THOSE PARTICIPANTS WHO PLAN TO ATTEND THE HEARING VIRTUALLY <u>AND</u> WISH TO OFFER ORAL COMMENT

**If you plan to attend virtually and wish to make an oral public comment** during the public hearing, you must follow the instructions below:

- Virtual Oral public comments will be received during the public hearing from those persons who have submitted an email to Princy.Doss@doli.virginia.gov no later than 12:00 PM on August 4, 2021 indicating that they wish to offer oral comment. Comments may be offered by these individuals when their name is announced by Ms. Doss. Oral comments will be restricted to 5 minutes each.
- When logging onto WebEx each person **must provide their full name** during the registration process upon entering the meeting. **Do not use the default username** as it is imperative that the meeting organizer be able to determine who is in attendance based on their registration name.
- Failure to follow these specific registration instructions will restrict your ability to participate with oral remarks.
- If you wish to make a virtual oral comment and will be utilizing the "audio conference only" option to witness the hearing, you must provide the phone number you will be calling in from in your email to Ms. Doss so that the administrator will know whom to unmute at the appropriate time.
