The Board unanimously approved the Consent Special Order, authorized the Director or his designee to sign the order on the Board's behalf and authorized the Director to take appropriate legal action for violation of the Order.

In addition, the Board unanimously approved requesting the Office of Virginia's Attorney General to seek civil penalties authorized by Section 62.1-44.32 (a) of the Code of Virginia in this matter.
