3. Recognition Rod Hall, Chairman

A. Jack Kennedy - Region 1 Board Member

Rod Hall, Chairman

The Chairman recognized Mr. Kennedy, Region 1 representative, and thanked him for his years of service, with comments echoed by several board members. Mr. Kennedy thanked the chairman and his fellow board members noting that he was hopeful on the outlook of unmanned systems and air taxi.

B. Barbara Haxter - Accomack County Airport Manager

Rod Hall, Chairman

Chairman Hall acknowledged Ms. Haxter's service to Accomack County Airport and aviation. A resolution was read by Ms. Christie and presented to Ms. Haxter by Chairman Hall and Ms. Christie.

4. Update and Announcements:

A. Civil Air Patrol and VABA Report

Col. Elizabeth Sydow, CAP Bud Oakey, VABA

Colonel Elizabeth Sydow of the Civil Air Patrol provided a presentation on the Civil Air Patrol and its activities.

Mr. Oakey stressed the importance of aerospace education in local school systems. He reported a brief update on the JLARC findings regarding the aircraft parts sales tax exemption. He explained that JLARC suggested that private-owned aircraft should not qualify for the aviation parts and supplies tax exemption. He disagreed with that suggestion.

B. Danville Airport Presentation

Mark Adelman, Transportation Services Director

Mr. Adelman provided a detailed presentation, including videos, of enhancements and renovation plans for the Danville Airport.

C. DOAV Update

Mark Flynn, DOAV

Mr. Flynn introduced James Oliver, the agency's new Finance Manager. He announced that Breeze airways is flying out of Norfolk, with flights starting soon out of Richmond.

1. Advanced Air Mobility

Mr. Flynn reported the department is making progress and that he has assigned staff from agency divisions to work on the Advanced Air Mobility initiative. The department is at the idea phase with work starting on drafting state law language, following FAA activity on design standards, and identifying various groups to partner with on development.

2. Sustainable Aviation Fuel

Mr. Flynn reported that sustainable aviation fuel (SAF) is a new area for the department but is gaining popularity nationwide. The department is working with others to pursue development of SAF in Virginia. The department had contracted to receive research several years ago and is now revisiting. Major airlines and aviation businesses are very interested in pursuing biomass fuels as a green alternative. He added that Secretary Valentine has expressed great interest in SAF.

3. Aviation Special Fund Status

Mr. Flynn reported that revenues to the Aviation Special Fund have increased in the latter half of the fiscal year. As a result of greatly reduced spending and recently increased revenues, the Aviation Special Fund reserves are expected to realize a gain by the end of the fiscal year.

Mr. Kennedy recommended the agency explore electric powered aircraft in addition to Advanced Air Mobility and Sustainable Aviation Fuel.

D. FAA-FSDO Report

Mr. Dacey provided an update on the FAA-FSDO activities.

E. VAOC Report

Keith Holt, VAOC

Mr. Holt provided an update on VAOC activities, including the upcoming Virginia Aviation Conference scheduled for August 17-19 in Norfolk.

7. Public Comment Period

Rod Hall, Chairman

Mr. Rempe asked if the board members were aware of legislation in Massachusetts implementing a \$1,000 landing fee, or climate fee, adding that he expects this to kill general aviation in that state and have severe economic consequences. He then expressed concerns over a proposed change to the *Airport Program Manual* that he feels will defund the ability for local service airports to meet minimum federal standards for an approach to the runway whether an instrument approach or not. He referenced the Code of Federal Regulations, Title 14, Chapter I, Subchapter E, Part 77 noting that the federal government has codified 15:1 as a minimum safe approach. He added that Virginia's minimum licensing standards are 20:1, with five surrounding states setting standards at 15:1.

8. Board Member Comments and Reports

Rod Hall, Chairman

Region 1: Mr. Kennedy noted he enjoyed Mr. Adelman's presentation, adding it is interesting to see how the casino is affecting the airport. He questioned if there was any collaboration among airports who are located in the proximity of casinos. He thanked everyone for their kind comments.
