Gas Fitter Vocational Training Requirements

Eric Olson presented to the committee staff questions regarding applicants' inability to get 240 hours of vocational education in gas fitting to qualify to exam eligibility.

Mr. Olson will follow up with the Department of Labor and Industry regarding apprenticeship requirements for gas fitters. He will contact HVAC vocational education providers to provide a breakdown on how many training hours are allocated to gas fitting.

Eric Olson presented staff questions to committee regarding whether non-responsible managers should be allowed to take remedial education.

It was determined that the current practice of only allowing responsible managers to take remedial education would remain as it is.

D.C. Waiver Agreement

Adrienne Mayo presented a request for journeyman and master reciprocity (ELE) from D.C. She stated that the education and experience requirements are similar to Virginia.

North Carolina Waiver Agreement

Adrienne Mayo presented a request for an ELE reciprocity agreement from North Carolina had been received. She has emailed them a response to their request and is awaiting response. Staff is to ensure that language in agreement reflects the education and experience requirements are to be similar to Virginia.

Motion was made by Mr. Redifer and seconded by Mr. Hux to proceed. Motion was approved by unanimous vote. Members voting "yes" were: **Dyer, Groh, Hux, Middleton,** and **Redifer.**

Policy Interpretation – Commercial Buildings

The Committee discussed a policy change regarding the current commercial contractor exemption that requires amending due to statutory changes to the exemptions.

"For own use" means that the person performing or supervising the construction of a residential building must live in the residential building upon completion, unless they can be exempted based on the familial relationship as outlined in § 54.1-1101.8, and the person performing or supervising repair of or improvements to a commercial building must first occupy all or part of the building and operate their business from that occupancy. The Board stated that there should be no misunderstanding that a person who performs or supervises the construction of or improvements to any building with the intent to sell it must have a contractor's license.

Mr. Redifer made a motion seconded by Mr. Hux to recommend the change to the Board at its next meeting. Motion was approved by unanimous vote. Members voting "yes" were: **Dyer, Groh, Hux, Middleton,** and **Redifer.**
