Mr. Kirschner asked that the Road review the proposed revisions to the Guidance Document that will allow blanke permission for all licensed schools to utilize distance or online instruction methods for theory instruction.

Upon a motion by Mr. Quesenberry and seconded by Ms. Gilanshah, the Board voted to approve the revisions to the Guidance Document.

The members voting 'yes' were Ms. Dang, Ms. Gilanshah, Rev. Hill, Ms. LaPierre, Ms. Rogers, Mr. Quesenberry, and Mr. Roberts. There were no negative votes. The motion passed unanimously.

Mi. Kirschnet distributed a hand-out to the Board for its review regarding proposed revisions to language in the Barbers and Cosmetology regulations and the Esthetics regulations related to Department of Labor and Industry (DOC) apprentices hp cards. Previously submitted revisions had drawn objections during the public comment period due to the elimination of the requirement for apprentices to wear badges identifying them as such. The revised alternative language removed the reference to apprenticeship badges.

Upon motion by Mr. Roberts and seconded by Mr. Quesenberry, the Board voice to approve the revised alternative language to regulations 18 VAC 41-20 260 and 18 VAC 41-70-260.

The members voting 'yes' were Ms. Dang, Ms. Gilanshah, Rev. Hill, Ms. LaPierre, Ms. Rogers, Mr. Quesenberry, and Mr. Roberts. There were no negative votes. The motion passed unanimously.


