MINUTES OF MEETING

The Condominium Regulatory Review Committee of the Common Interest Community Board met on Tuesday, September 13, 2011, at the Department of Professional and Occupational Regulation (DPOR), 9960 Mayland Drive, 2nd Floor, Board Room 3, Richmond, Virginia 23233.

Mr. Melson, Chair, called the meeting to order at 9:50 a.m.

Call to Order

Mr. Colucci moved to approve the agenda. Mr. Kinser seconded the Approval of Agenda motion which was unanimously approved by: Colucci, Diamond, Kacani, Kinser, Melson, and Mercer.

Mr. Melson opened the floor for public comment. No members of the **Public Comment** public present requested to speak.

Period

Ms. Henshaw provided an updated time-line for developing the draft Review of Timeline

Condominium Regulations. Two additional Committee meeting dates for Regulations have been scheduled for October 4, 2011 and November 3, 2011. The Board must adopt proposed Condominium Regulations at the December 1st meeting.

Ms. Henshaw gave an update on the current status of the regulatory review process for the Condominium Regulations. The Notice of Intended Regulatory Action (NOIRA) has been published and the 30day public comment period ended on July 6, 2011.

Update on Regulatory Review **Process**

Ms. Henshaw provided the Committee with a draft of the Condominium Regulations that incorporates the suggested changes from the last Committee meeting pertaining to the public offering statement requirements. The Committee re-reviewed several provisions from the previous meetings, and reviewed half of the post-registration provisions. The Committee discussed the suggested revisions and updated changes to the draft text.

Review Draft CIC Condominium Regulations

Ms. Thompson arrived at 10:00 a.m.

Arrival_of Committee Member

The Committee continued its review of the draft Condominium Regulations. The Committee recommended that advice be obtained from Board counsel on a recurring topic related to the legality of Regulations imposing restrictions on a unit owner's right to bring legal action against a declarant or association.

Arrival of Committee Member

The Committee continued its review of the draft Condominium Regulations. The Committee requested Mr. Colucci and Mr. Diamond redraft the section on encumbrances. The Committee requested Mr. Colucci and Mr. Diamond redraft the section on budgets and develop guidelines for providing a multi-year budget. The Committee completed its review of the public offering statement provisions in the draft Condominium Regulations.

The Committee recessed for lunch from 11:45 a.m. to 12:36 p.m.

The Committee continued its review of the draft Condominium Regulations. The Committee agreed by consensus with the implementation of a fee for filing an annual report. Ms. Henshaw indicated that a fee would be developed at a later date by the agency's

financial division. Ms. Trigiani suggested staff look at other states' laws for an alternative definition of "material change." After much discussion, the Committee deferred this item to later in the meeting.

The Committee continued its review of the draft Condominium Review Draft CIC Regulations.

Condominium Regulations

The Committee recessed at 2:12 p.m. and reconvened at 2:43 p.m.

The Committee continued its review of the draft Condominium Regulations. The Committee could not agree on the wording for the sections dealing with filing an amended public offering statement and the current public offering statement. It was decided that the Committee provide two separate options for the Board to consider.

The Committee also agreed to organize teams to study and give feedback on certain topics to be considered in the regulations.

- 1. Encumbrances -- Mr. Colucci and Mr. Diamond
- 2. Budget -- Mr. Colucci and Mr. Diamond
- 3. Material Change -- Mr. Diamond and Ms. Trigiani
- 4. Filing of Public Offering Statement Amendments and Current Public Offering Statement Provisions -- Mr. Colucci and Mr. Diamond, and Mr. Mercer and Ms. Trigiani

After discussion, Committee members were asked to submit any ideas, comments, or suggestions on these sections to Ms. Henshaw by September 26th for discussion at the October 4, 2011, meeting.

The Committee discussed its plan for the next Committee meeting. The Committee continued its discussion of topics that need to be addressed in the Common Interest Community Board Condominium Regulations. At the next Committee meeting, the Committee will review the revisions to the regulations regarding public offering statement requirements; re-review of encumbrances and budget in public offering statement provisions; material change; filing of amended public offering statement, and what constitutes a current public offering statement in

post-registration provisions; all other post-registration provisions; general provisions; application requirements; registration; and marketing. Staff will prepare a revised draft of Condominium Regulations in accordance with the Committee's comments for the next Committee meeting. In addition, the work from this meeting will be reported to the Board at its September 22nd meeting. The Committee requested Ms. Henshaw provide via e-mail word versions of the draft regulations so that Committee members could make suggested revisions.

The Board members serving on the Committee were reminded to complete their conflict of interest forms and travel vouchers.
