Public Comment Period

The Board discussed House Bill 2275 which was passed by the General Assembly and signed into law by Governor McDonnell. It provides an extension of the declarant control period for expandable condominiums within certain parameters. In addition, this bill contains an enactment clause requiring the Board to develop the disclosure statement required in accordance with subsection B of § 55-79.74 of the Code of Virginia within 30 days of the act becoming effective.
