Additionally, Dr. Butt moved that Ms. Sacksteder and Ms. Lee attend the closed meeting because their presence in the closed meeting is deemed necessary and their presence will aid the Committee in its deliberations. The motion was seconded and passed.

Reconvene: Dr. Butt moved that the Committee certify that it heard, discussed or considered only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act and only such public business matters as were identified in the motion by which the closed meeting was convened. The motion was seconded and passed.

The sanctions reported by Ms. Sacksteder were that Dr. Carter was issued a reprimand and shall pay a \$20,000.00 monetary penalty.

Within 6 months from the date of entry of the Order, Dr. Carter shall complete a 7 hour continuing education course in the subject of recordkeeping and risk management; 10 hour continuing education course in the subject of diagnosis and treatment planning; and a 10 hour continuing education course in the subject of restorative treatment, with 8 of the 10 hours being clinical hands-on.


Dr. Carter is prohibited from performing root canal therapy and crown preparation/placement for 3 years from the date of entry of the Order.

Dr. Carter is also subject to two unannounced patient records audits within 2 years from the date of entry of the Order.

Dr. Butt moved to adopt the decision of the Committee. The motion was seconded and passed.
