CLOSED SESSION: Upon a motion by Dr. Ransone, and duly seconded by Mr. Marchese, the Board voted to convene a closed meeting pursuant to §2.2-3711.A (27) of the Code of Virginia, for the purpose of deliberation to reach a decision in the matter of Dr. Hameed. Additionally, she moved that Ms. Mitchell, Ms. Deschenes and Ms. Wood attend the closed meeting because their presence in the closed meeting was deemed necessary and would aid the Board in its deliberations.




