Regulations:

Ms. Yeatts presented updates on regulations and legislation.

Ms. Ault moved that the Board oppose HB 545, regarding a prescription monitoring program.

The motion was seconded and carried unanimously.

Ms. King moved to recommend that if HB 664 on health professionals required to report injuries is passed, the inclusion of licensed practical nurse in those required to report.

The motion was seconded and carried unanimously.

Dr. Conroy moved that the Board support HB 44 regarding nurses pronouncing death under certain circumstances.

The motion was seconded and carried unanimously.

Dr. Conroy moved that the Board support SB 101 relating to allowing physical therapists to accept referrals from nurse practitioners.

The motion was seconded and carried unanimously.

Dr. Conroy moved that the Board recommend that HB 665 be amended to state that applicants would not be required to take the CGFNS exam but undergo CGFNS credential review before beginning 30 days of practice pending NCLEX.

The motion was seconded and carried unanimously.

After discussion of HB 1128 Ms. Hartz moved to support data collection but oppose the use of licensing fees because it is not central to the Board of Nursing mission and further that the Board is currently unable to support electronic system for certification, registration and licensure application as technology is not available to assure identity.

The motion was seconded and carried unanimously.

Dr. Conroy moved that the Board does not find HB 270 regarding staffing standards in operation rooms in conflict of the intent of the Nurse Practice Act or its regulations and circulating responsibilities may not be delegated to unlicensed personnel.

The motion was seconded and carried unanimously.

Policy Forum:

Practical Nursing Educators were present and dialogued with the Board about practical nursing programs.

RECONVENTION: The Board reconvened at 1:25 P.M.

Dr. Younger introduced new appointee JoAnn Tillett and informed the Board Ms. Tillett will be unable to complete her term.
